Project: To construct a four-story and rear addition to an existing, two-story, semi-detached mixed-use building in the MU-4 Zone.

You will need to create a username and password if you have not done so already.

HOW TO PARTICIPATE IN THE VIRTUAL HEARING AND/OR SUBMIT COMMENTS:

A. Watch/listen to the hearing:

C. Submit a statement into the record: After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are **required to be sent at least 24 hours before the hearing**.

- Hard copies of documents will not be accepted at this time.


REFERRAL TO GOVERNMENT AGENCIES
