2. Select the hearing date and case number from the drop down lists.
3. Fill in the online form with the name and contact information that will be used the day of the hearing.
4. Select your Affiliation and Testimony Type from the drop down lists.
5. Check the Oath box and click "Submit".

If you are unable to sign up online, call Robert Reid at 202-727-5471 to sign up to testify. ***Note: Those attending the hearing applying for party status must call Robert Reid in order to register.*** Currently the system does not have a "filing for party status" option in the digital signup process.
