- the lot occupancy requirements of Subtitle E § 304.1 (pursuant to Subtitle E § 5201 and Subtitle X § 901.2)
- the rear yard requirements of Subtitle E § 306.1 (pursuant to Subtitle E § 5201 and Subtitle X § 901.2)

**Project:** To construct a rear, two-story addition with deck, to an existing, attached, two-story with cellar, principal dwelling unit, in the RF-1 Zone.
