Since the original application was filed, the Applicant has refined the plans for the development of the Property such that now only the following four special exceptions are required: (1) relief from the parking requirements set forth in Subtitle C, Section 701.5, (2) relief from the loading requirements of Subtitle C, Section 901.1, (3) relief to permit eating and drinking establishment uses in a penthouse pursuant to Subtitle C, Section 1501.1, and (4) relief from the rear yard requirements of Subtitle G, Section 207.9. A more complete update to the application will be submitted to the Board twenty-one days prior to the July 31, 2024 public hearing.
