## SY 2024-25 Eagle Care Registration

Dear Capital City Families,

We are excited to welcome your students back to school this August. We want to share important information about the Eagle Care program.

### Cost

We are still waiting to receive our child care license from OSSE, so families will not be able to receive vouchers until the process is complete.

- We will start the year with the same pricing plan as we used last year: Full-time after care for \$372/month or \$115/month for families that qualify for Free and Reduced Meals. (See "Eagle Care Pricing Information: SY 2024-2025" below).
- Once we receive our license, we will no longer offer a reduced rate. Instead, families who do not want to pay the full price will need to apply for vouchers, which will cover the majority of the cost of the program. (See "Steps to Apply for Childcare Vouchers" below). We know this process can be confusing for families, and we are prepared to assist you if you have questions or want help scanning your paperwork.

### Payment Options

**1. Pay Online:**

To access the parent payment portal online, go to [payschoolscentral.com](https://payschoolscentral.com). Create an account and add your student using the school's Student ID. You can make payments via credit card, debit card, or ACH.

**2. Credit or Debit Card:**

You can make a credit or debit card payment at the front desk or with Steve LeBoo. Tell the Front Desk Manager that you are making an Aftercare/Beforecare payment and the name, grade and amount due.

**3. Check or Money Order:** Checks and money orders can be submitted at the Capital City main front desk or with Steve LeBoo. They should be addressed to "Capital City PCS" and should have your student's name, grade and indicate that the payment is for Aftercare/Beforecare in the memo line.

***Note: Cash is no longer accepted.***



## Steps to Apply for Childcare Vouchers

- 1) **Determine if you are likely to qualify for vouchers.** You are likely to qualify if these three things are true:

- The child's parents work, are looking for work, are in job training, or receive TANF.
- The child is a citizen or legal resident.
- Your family income is below the cutoff:

Families with incomes above the cutoff will continue to pay the full rate for before- and after-care. If you think your family will not qualify for vouchers and you are experiencing financial hardship, please contact the Director of Eagle Care to discuss your circumstances.

- 2) **Wait.** You cannot apply for vouchers until our license is official. We expect to receive our license in late June or early July and we will let you know as soon as you can start to apply.
- 3) **Collect paperwork.** You will need to submit the following documents when you apply:
- Parent's government ID (Driver's license or passport)
  - Children's birth certificates
  - Verification of child's legal immigration status (passport, legal permanent resident card, I-94, Visa, or other immigration documentation)
  - Verification of residency (rent receipt, mortgage payment, lease, utility bill, etc)
  - Income verification (two recent pay stubs, statement from employer, self-employed income documents)
  - Proof that parents are working, disabled, or in school (pay stubs, class schedule, job training letter, TANF participation)
