SUMMARY ORDER

RELIEF REQUESTED. The application requests the following relief in order to construct a rear addition to an existing, semi-detached, four-story with basement, mixed use building in the MU-5A/DC zone:

- Special Exception from the rear yard requirements of Subtitle G § 207.6, pursuant to Subtitle G § 207.14, Subtitle G § 5200.1, and Subtitle X § 901.2
- Special Exception from the lot occupancy requirements of Subtitle G § 210.1, pursuant to Subtitle G § 5200.1, and Subtitle X § 901.2

The application was accompanied by a memorandum from the Zoning Administrator, certifying the required relief. (Exhibit 8.)

<u>PARTIES</u>. The parties to this case were the Applicant and Advisory Neighborhood Commission ("ANC") 2B, the "affected ANC" pursuant to Subtitle Y §§ 101.8 and 403.5(b) of the Zoning Regulations (Title 11 of the DCMR, Zoning Regulations of 2016, to which all references are made unless otherwise specified).

At the public hearing on June 12, 2024, the Board granted party status in opposition to Abdollah Poozesh, owner of property which abuts the subject property. On October 22, 2024, the party opponent withdrew his party status in opposition to the application (Exhibit 50), after execution of an agreement with the Applicant which addressed his concerns. (See Exhibit 51.)

¹ The application was originally scheduled for hearing on June 12, 2024. The Board addressed party status and postponed hearing of the merits to July 31, 2024 at the Applicant's request. On July 31st, the merits were heard and the Board continued the hearing to October 23, 2024, where the hearing procedures were completed and the application was decided.

NOTICE OF THE APPLICATION AND PUBLIC HEARING. The Board of Zoning Adjustment (the "Board") referred the application to the appropriate agencies and provided proper and timely notice of the public hearing in accordance with Subtitle Y § 402.1.

ANC REPORT. The ANC's report indicated that at a regularly scheduled, properly noticed public meeting on May 8, 2024, at which a quorum was present, the ANC voted to support the application. (Exhibit 17; Exhibit 18A (duplicate).) The ANC report raised no issues or concerns.

<u>OFFICE OF PLANNING ("OP") REPORT.</u> OP submitted an original report indicating that OP was unable to make a recommendation for the application. (Exhibit 26.)

On July 19, 2024, OP submitted a supplemental report recommending approval of the application. (Exhibit 36.)

<u>DISTRICT DEPARTMENT OF TRANSPORTATION ("DDOT") REPORT.</u> DDOT did not submit a report to the record related to this application.

<u>Persons in Support</u>. The Board received a petition with multiple signatures in support of the application. (Exhibit 39.)

CONCLUSIONS

Pursuant to Subtitle Y § 604.3, the order of the Board may be in summary form where granting an application when there was no party in opposition. As a summary order, it does not constitute binding legal precedent on the Board and shall not be considered by the Board in evaluating future applications.

Based upon the record before the Board, and having given great weight to the appropriate reports and recommendations filed in this case, the Board concludes that the Applicant has met the burden of proof that the requested special exception relief can be granted because:

- It is in harmony with the general purpose and intent of the Zoning Regulations and Map;
- It will not tend to affect adversely the use of neighboring property; and
- Pursuant to Subtitle X § 901.2(c), the relief satisfies the specified conditions for special exception relief.

DECISION

Based on the case record and the testimony at the hearing, the Board concludes that the applicant has satisfied the burden of proof for the requested relief:

- Special Exception from the rear yard requirements of Subtitle G § 207.6, pursuant to Subtitle G § 207.14, Subtitle G § 5200.1, and Subtitle X § 901.2
- Special Exception from the lot occupancy requirements of Subtitle G § 210.1, pursuant to Subtitle G § 5200.1, and Subtitle X § 901.2

Accordingly, it is **ORDERED** that the application is **GRANTED** consistent with the revised plans shown in Exhibit 45B (rear demolition plan) and Exhibit 49A1, slides 3, 12, and 14-17 (plans and demolition plan) of the record, as required under Subtitle Y §§ 604.9 and 604.10.
