Good afternoon Mr. Reid and Board of Zoning Adjustment Members and Office of Planning Staff:

I wanted to send an update following up to the MOA that I signed regarding BZA case 21143 - for 3100 R Street.

I'm writing to withdraw my opposition to BZA 21143 as a list of conditions were agreed upon and signed by me, with the Board of Trustees. I do hope that the BZA supports this list of conditions and that my withdrawal will allow me to speak quickly to explain my rationale on October 23rd should there be any need to clarify or answer questions you may have.
