As the Office of Zoning is making final preparations for the **Board of Zoning Adjustment Public Hearing of December 4, 2024**, a review of the case record in the matter of **BZA Application No. 21167 of Bezhad Hossienkhani, Trustee** shows that no report has yet been filed on behalf of ANC 2G in this case.

If ANC 2G does not intend to file a report in this matter, it would be helpful if a letter or statement, on the letterhead of ANC 2G and signed by either Vice-Chair McCarty or yourself, be filed to the record stating that ANC 2G is taking no formal position on the application.

If ANC 2G does intend to file a report in this matter, it would be most helpful to the Board if the report, using either ZC/BZA Form 129 Advisory Neighborhood Commission Report, or on the letterhead of ANC 2G, could be filed to the record no later than Tuesday, December 3, 2024, either directly via the **Interactive Zoning Information System (IZIS)**, or via email at bzasubmissions@dc.gov. Should ANC 2G wish to appoint a representative Commissioner to appear at Wednesday's hearing, it would be helpful to have a statement designating that Commissioner into the record. As with the ANC Report, this authorization must be signed by either Vice-Chair McCarty or yourself.

If the Office of Zoning can provide ANC 2G any assistance in furtherance of this goal, please let me know.
