RE: BZA Case No. 21177 – 501 New York Avenue NW Applicant's Cover Letter with Motion to Late File Expert Witness

Chairperson Hill and Honorable Members of the Board:

The Applicant filed an application for special exception relief under 11 DCMR Subtitle X § 900.3 for the enlargement of the existing conforming large scale government use in the D-4-R zone. Due to changes in the Applicant's team as a result of scheduling conflicts, the Applicant would like to qualify Dana Foerster as an expert witness to provide testimony regarding the architectural plans filed at Exhibit 12.

Pete Obarowski of DLR Group, the architecture firm who prepared the architectural plans for the project in the subject BZA application, was anticipated to serve as the Applicant's expert witness on architecture. However, efforts to coordinate availability took longer than expected and resulted in Mr. Foerster needing to testify in place of Mr. Obarowski. Mr. Foerster is a senior project architect and designer with DLR Group and has over 15 years of architecture experience. A copy of Mr. Foerster's resume is attached at <u>Tab A</u>. Mr. Foerster is qualified to testify as an expert witness.

The Applicant has also enclosed a Motion to Late File, which is attached at <u>Tab B</u>. The hearing date is scheduled for October 9, 2024, with supplemental material due 30 days in advance on September 9, 2024. *See* Subtitle Y § 300.15. As such, this filing is made late due to changes in the Applicant's team.
