that I am missing? Police agencies regular users - MPD, Metro Transit, U.S. Capital Police, Park Police, Uniformed Secret Service Police

Concerning the traffic at the proposed central cell block please explain to me what happens when there is a caravan of police cars or vans. When one car is in the garage where will all the other police vehicles be sitting with their detainees? Not clear on your reference of “caravan of police cars”? If there is a large amount of arrests coming from various police Districts, then DOC will coordinate staggered arrivals from districts where being initially held. DOC is also instituting “call-ahead” on such drop-offs.
