As the Office of Zoning is making final preparations for the **Board of Zoning Adjustment Public Hearing of October 30, 2024**, a review of the case record in the matter of **Board of Zoning Adjustment Application No. 21182 of 2021 Project H SPV, LLC**, show that no report has yet been filed on behalf of ANC 2D in this case.

Should ANC 2D intend to have a representative Commissioner appear at Wednesday's hearing, it would be helpful to have that Commissioner designated in the ANC Report, or the letter of no position, as well.

If the Office of Zoning can be of any assistance to ANC 2D in furtherance of this goal, please let me know.
