How to participate as a party

Any person who desires to participate as a party in this case must request party status and must comply with the provisions of Subtitle Y § 404.1. Persons seeking party status must submit a Form 140 - Party Status Application through IZIS at https://app.dcoz.dc.gov/Login.aspx. The form is also available to download from OZ's website at: https://dcoz.dc.gov/page/zoning-forms. The request must be filed the Board NO LESS THAN 14 DAYS PRIOR TO THE ORIGINAL DATE SET FOR THE HEARING (or 14 days prior to a scheduled public meeting if seeking advanced party status consideration).

A party has the right to cross-examine witnesses, to submit proposed findings of fact and conclusions of law, to receive a copy of the written decision of the Board, and to exercise the other rights of parties as specified in the Zoning Regulations.

Except for an affected ANC, any person or entity that desires to participate as a party in this case must clearly demonstrate that the person's interests would likely be more significantly, distinctly, or uniquely affected by the proposed zoning action than other persons in the general public.
