The Applicant has made consistent efforts to engage with ANC 7F, reaching out seven times since filing the application. Despite these repeated attempts, the ANC has not provided any response.

In addition, the Applicant proactively contacted neighbors, including via certified mail as demonstrated by the receipts included in this submission. The Applicant received eight letters of support, including one from the adjacent neighbor to the east at 4239 Eads Street, NE. The adjacent owner to the west does not reside in said residence, and the building appears to be unoccupied by any tenants.
