Scope of Work




- Verizon proposes the installation of a new 94' tall monopole as well as auxiliary equipment including an emergency backup generator
- Monopole will replace existing 82' tall light pole
- Existing light fixture will remain on the tower at its existing elevation
- Verizon antennas will be installed near the top of the pole, with room for additional wireless carriers to collocate onto the tower

Background




- Verizon Wireless expressed a service need in the area
- Several factors were considered, including site elevation, feasibility of constructing a replacement tower or collocating on an existing structure, and willingness of the landowner to work with Verizon
- Utilizing existing light standard allows facility to blend in with existing features


Site Plan



Site Elevation




