Scope of Work



- T-Mobile is requesting Special Exception Relief pursuant to § 13.13
- T-Mobile proposes to install a monopole 120 feet in height
- The new monopole would accommodate the relocation of existing antennas on the roof at 3720 Martin Luther King Jr. Avenue SE, which are currently not in operation due to vandalism
- Relocation on the monopole would continue coverage in the neighborhood and allow for collocation of other carriers' antennas
- The monopole is proposed to be located on the northern edge of the existing parking area on the eastern side of the property

Background



- The proposed T-Mobile monopole is strategically designed to visually integrate with the existing vertical infrastructure, including nearby light poles and utility structures, minimizing visual impact and maintaining consistency with the built environment. (Due to constructability and height, the possibility of swapping an existing light standard for a monopole was not feasible.)
- The monopole will be DGS owned and maintained by T-Mobile.
- Based on the satisfaction of the criteria and conditions within § 13.13, the proposed monopole use for T-Mobile would be in harmony with the intent and purpose of the Zoning Regulations.

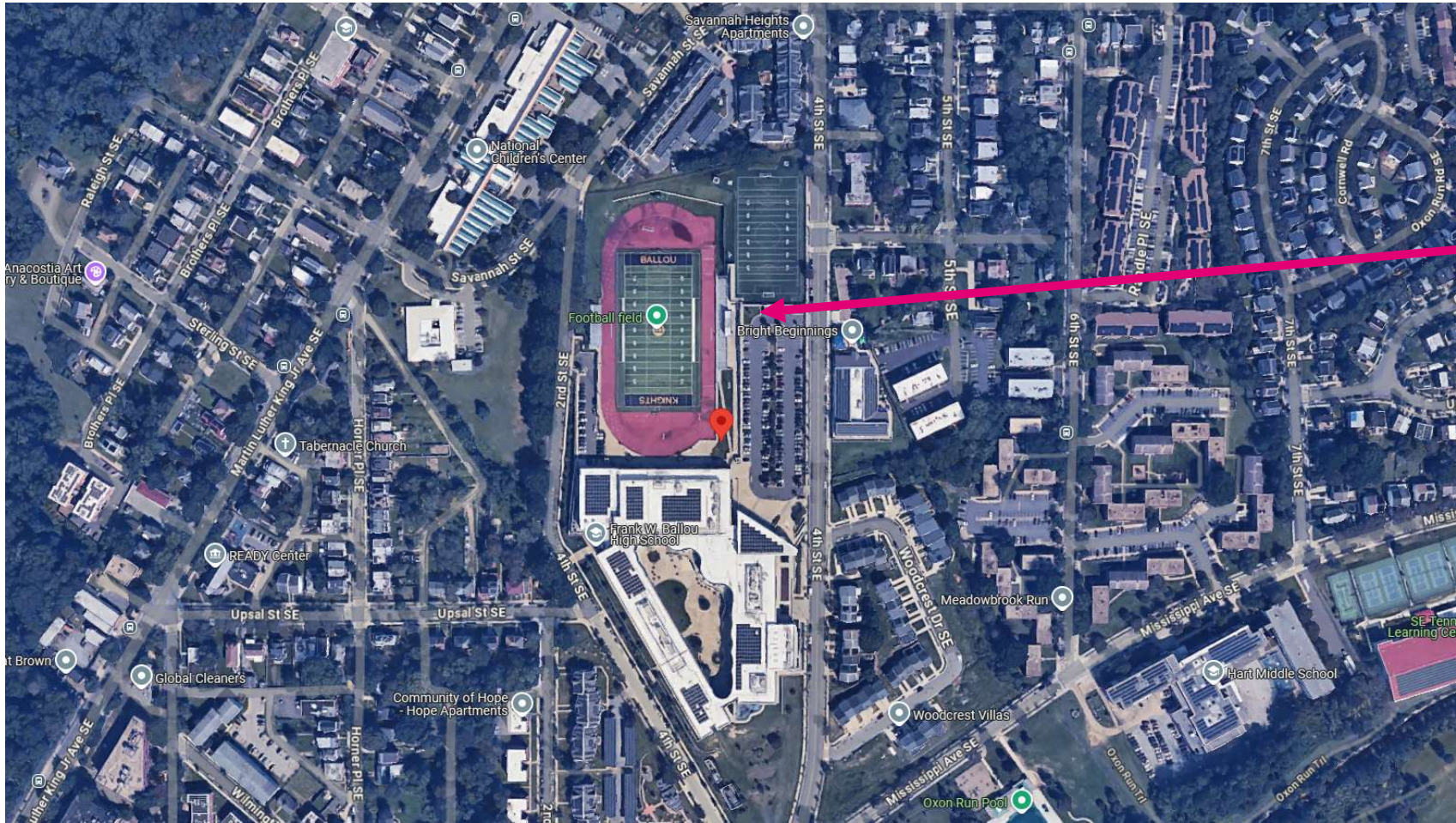
