Dear Members of the Board,

ANC 6C writes to provide its views on the applicants' pending motion for the Board to accept untimely filings into the record. We oppose the motion in part and express no objection in part.

We strongly object to acceptance of Exhibit 30B, which is a revised Notes and Computations sheet allegedly created by Ernesto Warren in the Office of the Zoning Administrator (ZA). We inquired about the propriety of such a document without a corresponding memorandum signed by the ZA; in response, the Deputy ZA advised on May 16 that "[t]he Notes and Computation Sheet should go hand-in-hand with a Referral Memo." See the attachment to this letter (email from Deputy ZA Elisa Vitale).

Whether or not Mr. Warren was actually involved in the creation of this document, the Deputy ZA's statement makes clear that the Board should not accept a bare Notes and Computations sheet unaccompanied by a ZA-approved memorandum. As a result, we oppose the acceptance of Exhibit 30B and cross-move to have it stricken from the record.

ANC 6C has no objection to acceptance of the remaining documents in the applicants' motion. For clarity, our non-objection does not concede the accuracy or completeness of these filings. To the contrary, we believe these documents contain significant errors and misrepresentations that can be addressed in our future written submission and at the hearing.

Elisa,

I have a question about the procedures for BZA applicants who seek a ZA memo instead of self-certifying.

An applicant in ANC 6C submitted a memo from the

ZA <https://app.dcoz.dc.gov/Exhibits/2010/BZA/BZATmp4553/Exhibit23.pdf> (dated March 6) and a Notes & Computations sheet <https://app.dcoz.dc.gov/Exhibits/2010/BZA/BZATmp4553/Exhibit28.pdf> bearing the name of

reviewer Ernesto Warren. After filing a series of revised plats and construction drawings, yesterday the applicant submitted a substantially different Notes & Computations sheet <https://app.dcoz.dc.gov/Exhibits/2010/BZA/21295/Exhibit47.pdf> dated 5/13 with no accompanying ZA memo.

Is this kosher? Did Mr. Warren perform a new review or did the applicant elect to alter the document without presenting it to OZA? Either way, doesn't this require an updated ZA memo based on the new drawings & calculations?
