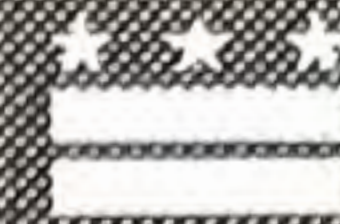

The undersigned owner hereby authorizes the undersigned agent to act on the owner's behalf in this matter.
