The Commission will be requesting a postponement for BZA Case No. 21406 to allow additional time to engage the community and receive public feedback on the project.

Based on the preliminary information provided and our meeting with the owner, it is likely that the Commission would support the project. However, as we enter the new year, we have not yet had the opportunity to complete our due diligence to ensure that residents have a meaningful opportunity to provide input.

From what we have reviewed thus far, the proposal aligns with the type of development the Commission typically supports in our community. That said, our recommendation is to request a postponement to allow time for community engagement and to proceed thoughtfully from there.

We hope you will agree with this approach and look forward to continuing the conversation soon.
