313 2nd Street, NE (Square 756, Lots 47, 52, 827, and 828)**

SUMMARY ORDER

RELIEF REQUESTED. The application requests the following relief in order to create a single record lot, raze an existing accessory structure, and construct a detached, two-story primary building (Parish Hall) on the same lot as three existing primary buildings in the RA-2/CAP zone:

- Special Exception pursuant to Subtitle C § 305.1, for a waiver from Subtitle C § 302.1 to allow multiple primary buildings on a single record lot, pursuant to Subtitle X § 901.2
- Area Variance from the theoretical subdivision vehicular ingress/egress width requirements of Subtitle C § 305.3(b), pursuant to Subtitle X § 1002 (*24 ft. minimum width required; 12 ft. existing; 12 ft. proposed*)
- Area Variance from the rear yard requirements of Subtitle F § 207.1, pursuant to Subtitle X § 1002 (*4 in. per foot of principal building height, 15 ft. minimum required; 7 ft. 3 in. (church) and 6 ft. (parish hall) proposed*)

The zoning relief requested in this case was self-certified. (Exhibit 6.)

PARTIES. The parties to this case were the Applicant and Advisory Neighborhood Commission ("ANC") 6C, the "affected ANC" pursuant to Subtitle Y §§ 101.8 and 403.5(b) of the Zoning Regulations (Title 11 of the DCMR, Zoning Regulations of 2016, to which all references are made unless otherwise specified).

NOTICE OF THE APPLICATION AND PUBLIC HEARING. The Board of Zoning Adjustment (the "Board") referred the application to the appropriate agencies and provided proper and timely notice of the public hearing in accordance with Subtitle Y § 402.1.

ANC REPORT. The ANC did not submit a report to the record.

OFFICE OF PLANNING ("OP") REPORT. OP submitted a report recommending approval of the application. (Exhibit 20.)

DISTRICT DEPARTMENT OF TRANSPORTATION (“DDOT”) REPORT. DDOT submitted a report indicating that it had no objection to the application because it concluded that the relief would not result in any adverse impacts to the District’s transportation network. (Exhibit 24.)

ARCHITECT OF THE CAPITOL (“AOC”) REPORT. AOC submitted a report indicating that it had no objection to the application. (Exhibit 23.)

CONCLUSIONS

Pursuant to Subtitle Y § 604.3, the order of the Board may be in summary form where granting an application when there was no party in opposition. As a summary order, it does not constitute binding legal precedent on the Board and shall not be considered by the Board in evaluating future applications.

Based upon the record before the Board, and having given great weight to the appropriate reports and recommendations filed in this case, the Board concludes that the Applicant has met the burden of proof that the requested special exception and variance relief can be granted because:

- It is in harmony with the general purpose and intent of the Zoning Regulations and Map;
- It will not tend to affect adversely the use of neighboring property;
- Pursuant to Subtitle X § 901.2(c), the relief satisfies the specified conditions for special exception relief;
- There exists an exceptional or extraordinary situation or condition related to the property;
- The exceptional condition creates a practical difficulty, in the case of an area variance, or an undue hardship, in the case of a use variance, in complying with the Zoning Regulations;
- The relief can be granted without substantial detriment to the public good; and
- The relief can be granted without substantially impairing the intent, purpose, and integrity of the zone plan as embodied in the Zoning Regulations and Map.

DECISION

Based on the case record and the testimony at the hearing, the Board concludes that the applicant has satisfied the burden of proof for the requested relief:

- Special Exception pursuant to Subtitle C § 305.1, for a waiver from Subtitle C § 302.1 to allow multiple primary buildings on a single record lot, pursuant to Subtitle X § 901.2
- Area Variance from the theoretical subdivision vehicular ingress/egress width requirements of Subtitle C § 305.3(b), pursuant to Subtitle X § 1002 (*24 ft. minimum width required; 12 ft. existing; 12 ft. proposed*)
- Area Variance from the rear yard requirements of Subtitle F § 207.1, pursuant to Subtitle X § 1002 (*4 in. per foot of principal building height, 15 ft. minimum required; 7 ft. 3 in. (church) and 6 ft. (parish hall) proposed*)

Accordingly, it is **ORDERED** that the application is **GRANTED** consistent with the plans shown in Exhibits 4A1 and 4A2 of the record, as required under Subtitle Y §§ 604.9 and 604.10.

PURSUANT TO 11 DCMR SUBTITLE Y § 702.1, THIS ORDER SHALL NOT BE VALID FOR MORE THAN TWO YEARS, UNLESS, WITHIN SUCH TWO-YEAR PERIOD, AN APPLICATION FOR A BUILDING PERMIT FOR THE ERECTION OR ALTERATION APPROVED IS FILED WITH THE DEPARTMENT OF BUILDINGS FOR THE PURPOSE OF SECURING A BUILDING PERMIT, OR A REQUEST FOR A TIME EXTENSION PURSUANT TO SUBTITLE Y § 705 IS FILED PRIOR TO THE EXPIRATION OF THE TWO-YEAR PERIOD AND THE REQUEST IS GRANTED. PURSUANT TO SUBTITLE Y § 703.10, NO OTHER ACTION, INCLUDING THE FILING OR GRANTING OF AN APPLICATION FOR A MODIFICATION PURSUANT TO SUBTITLE Y §§ 703 OR 704, SHALL TOLL OR EXTEND THE TIME PERIOD.

PURSUANT TO 11 DCMR SUBTITLE Y § 604, APPROVAL OF AN APPLICATION SHALL INCLUDE APPROVAL OF THE PLANS SUBMITTED WITH THE APPLICATION FOR THE CONSTRUCTION OF A BUILDING OR STRUCTURE (OR ADDITION THERETO) OR THE RENOVATION OR ALTERATION OF AN EXISTING BUILDING OR STRUCTURE. AN APPLICANT SHALL CARRY OUT THE CONSTRUCTION, RENOVATION, OR ALTERATION ONLY IN ACCORDANCE WITH THE PLANS APPROVED BY THE BOARD AS THE SAME MAY BE AMENDED AND/OR MODIFIED FROM TIME TO TIME BY THE BOARD OF ZONING ADJUSTMENT.
