This is a follow-up to a letter sent to you a couple of weeks ago about a property at 1908 Irving Street NE in Ward 5. The neighbor next to this property, Felicia Barber has solicited help from the Ward 5 community to oppose a planned development project next door (she lives at 1906) that she believes is going to be a warehouse for unrelated transient residents.

The 5B ANC Commission has been trying to push through a recommendation to approve this development for several months, in part, because a resident who lives quite a number of blocks away from this location said he/she thought it was a good idea. We've seen this before where the cosigning of one or two residents in a Single Member District (SMD) became the catalyst for an ANC group to make decisions/recommendations impacting an entire community without consult with, or input from, the larger stakeholders --YOU!

This letter provides 3 email address below. One is for Edward Borrego, ANC Commissioner for 5B01 who chairs the 5B meetings. The second is for Maya Vizvary. the ANC Commissioner pushing for approval of this project. And the third is to the BZA who will have a hearing on this project on June 24th .
