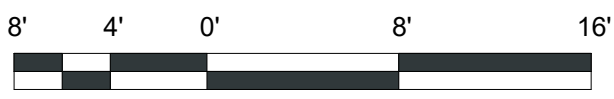
1 FLOOR PLAN - 3RD FLOOR

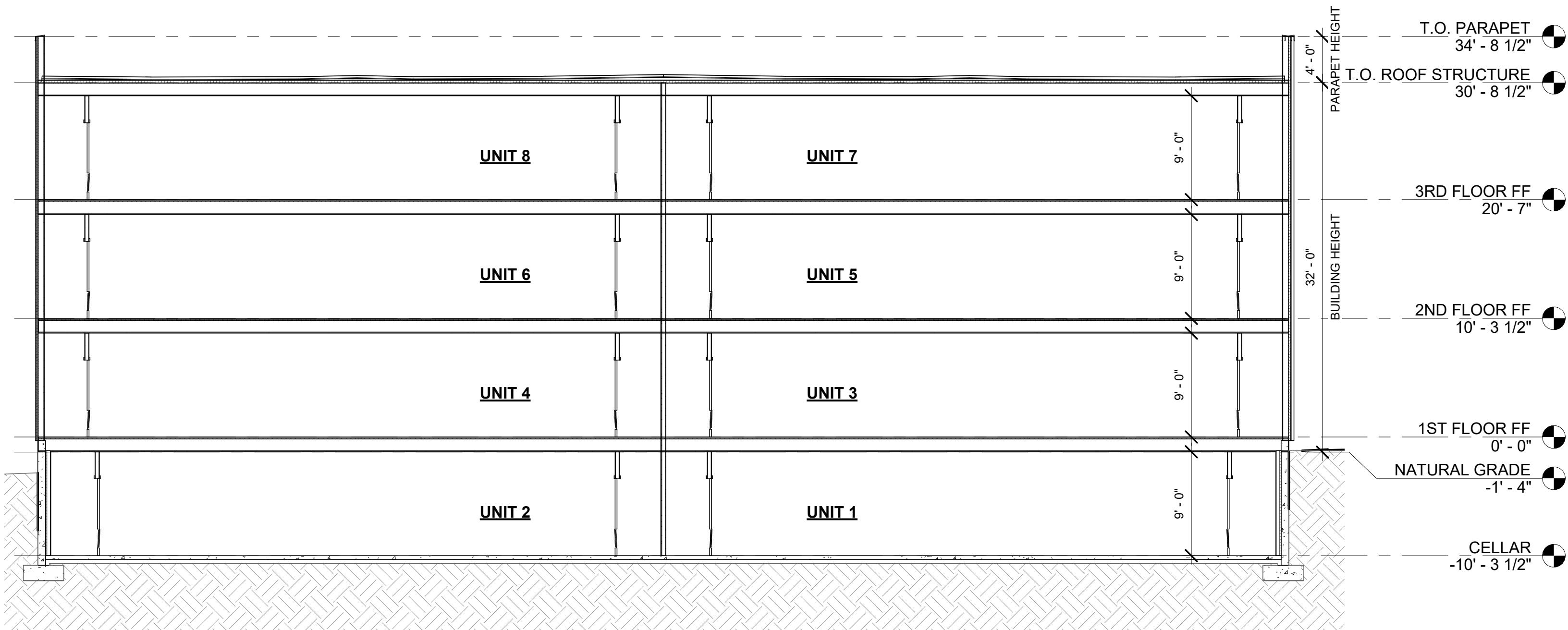

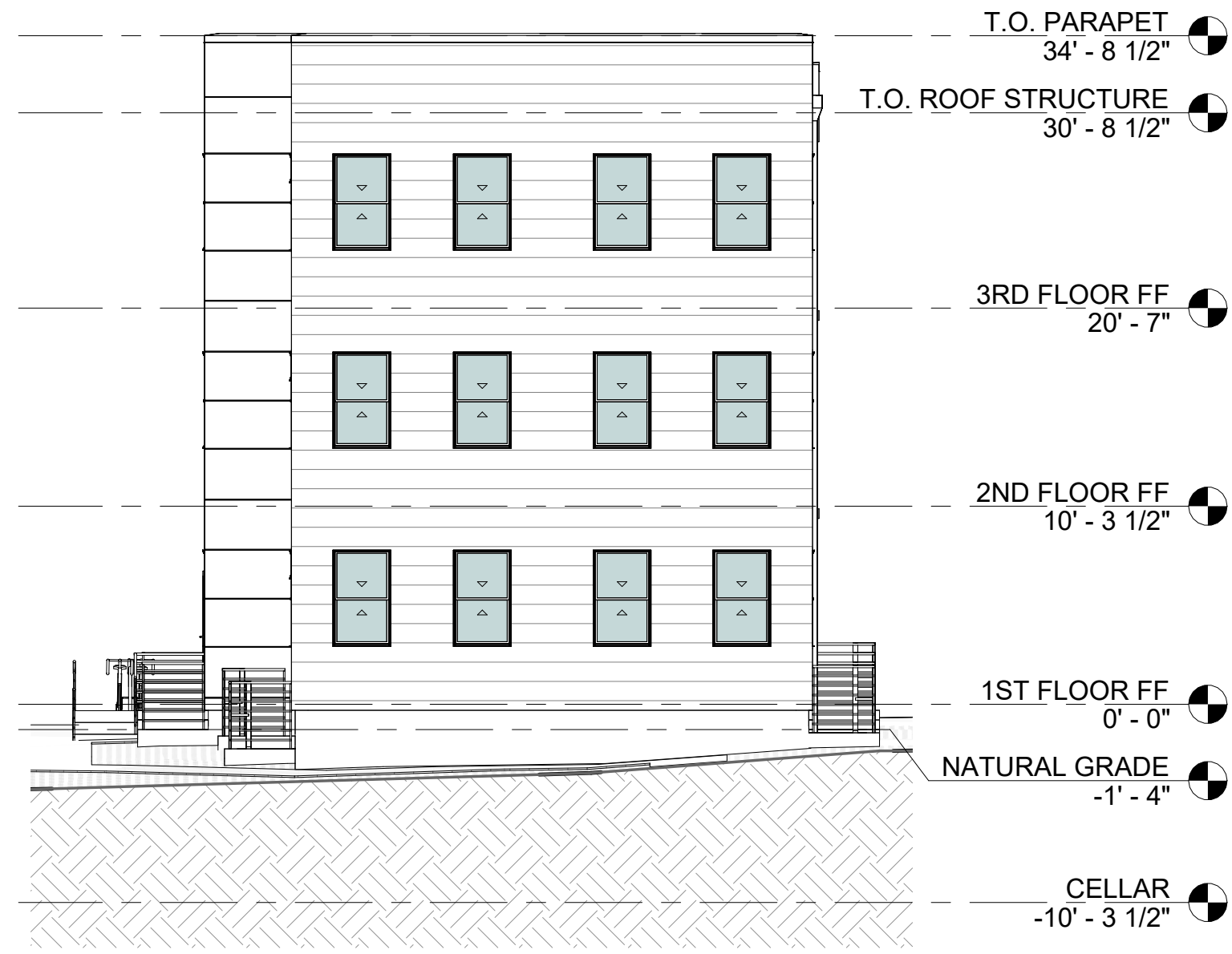
