• Streets & Sidewalks, Chair, Paul Harrison (paul@3lobos.com):

- 36th and Reno: working to improve the closed street, open green space and intersections.
- DDOT is working on their sidewalk repair plan for 2025 and will be in the neighborhood soon to review the areas that will be constructedincluding working with the DDOT arborist to protect trees.
- Schools & Universities. Chair, Commissioner Slatnick
 - Attended Sheridan Schools zoom meeting re: their construction schedule.
 Construction fencing will be erected during Christmas break and outdoor construction will begin in June.

VIII. Regular Agenda - Community Forum (continued)

- UDC: Juanita Gray
 - 4136 students registered and taking classes.
 - O MOMS New elevator work is ongoing. Interior work is ongoing. Garage parking prep work (cleaning, painting, and striping) is ongoing. MOM's exterior signage has been approved by CFA and is currently under permit review. Because we are approaching the 'blackout months' of November and December when retail is absorbing seasonal workers, it may be on MOMs best interest to postpone the opening of the store until earlier 2025 (a decision has not been made on the opening date).
 - The Whale tea: Interior work is ongoing. Amendment to the plumbing permit is pending. Opening date has not been confirmed yet.
 - Dog Haus: Construction drawings approved by UDC. Drawings are under permit review. Estimated opening later spring-early summer 2025
 - 4340 Connecticut Ave: Negotiations with potential tenant for the space occupied by VNMS did not result in a lease.
 - 4250 Connecticut Ave: UDC is currently in negotiations with a potential tenant for the restaurant space on the north side of Connecticut at 4250
 - Student Center: UDC is finalizing negotiations with a food & beverage franchise for the retail space in the Student Center.
 - Capital projects: Modernization of 2 elevators in Bldg. 39 (Administration Bldg.) is ongoing. One elevator will be back in service within the next two weeks. The other elevator is expected to be completed in December of 2024. Construction documents for the 4250 renovation project are currently under permit review.
 NIH Biomedical project is underway.
- Kathy Sykes-Connecticut Avenue Pollinator Program
 - Last weekend for community planting thanks the ANC for funding the project.
 - The leaves and stems of the plants are left after they bloom so they can provide a home for beneficial insects over the winter months. They may not look as beautiful as they do in bloom, but it is important to leave them in order to keep the insects and critters alive.
