### I. ANC and Office of Planning Notification

In accordance with **Subtitle Y § 300.8(l)**, the applicant has undertaken outreach to the **Advisory Neighborhood Commission (ANC 4D)** and the **Office of Planning (OP)**.

- On **September 1, 2025**, the applicant sent an introductory email to the ANC 4D commissioners and the Office of Planning, informing them of the project scope—a **third-floor addition, rear extension, and reconfiguration of existing units**—and attached the **Intended Use Statement** and **architectural drawings**.

I am reaching out on behalf of the owner, **Maria Cabieses**, to share the scope and purpose of the project:

**Scope of the Project:**

- Construction of a new third floor measuring approximately 41'-0" x 33'-0".
- First-floor rear addition of 5'-0" x 33'-0".
- Implementation of updated architectural planning along with new Mechanical, Electrical, and Plumbing (MEP) systems for the expanded and reconfigured spaces.
