

To all of our Patrons at Old City Market and Oven:

It has recently come to our attention that someone had filed a complaint with the Office of Zoning, that we were not in compliance with a zoning order. In 1983 the Zoning Board issued a variance allowing the Market to prepare food and sell to its customers. But the zoning order indicated that we could not have restaurant seating at the Market. As a result of the complaint, a Zoning Inspector came to the Market on Thursday and reported that we would have to remove the chairs we have in the basement.

As you know from visiting our store, we did have some tables and chairs in the basement which we permitted our patrons to use to sit, meet, talk, read, listen to music, or do whatever else they might like to do in a safe, friendly atmosphere. As of Thursday, January 4, 2017 we no longer have seating in the basement. We at the Market believe that the neighborhood wants and appreciates the opportunity to sit down and relax at our store. If you agree, we would ask that you come in to the store, beginning next week, and sign our petition, which we *will* then file with the Board of Zoning Adjustment,

requesting a zoning variance to permit our store to have seating.
