Please accept for filing the enclosed application of Southern Hills LP (the "**Applicant**") for a modification of significance to BZA Order No. 19819 for special exception and variance relief in order to construct a new multifamily development that will also include a new community service center. The Applicant is seeking reapproval of special exceptions pursuant to 11 DCMR Subtitle U § 421 for new residential development in the RA-1 zone; pursuant to Subtitle U § 320.1(b) for a community service center; and pursuant to Subtitle C § 305 to allow multiple buildings on a single lot utilizing theoretical lots. The Applicant reapproval of an area variance from the maximum height under Subtitle F § 303.1.
