At its November 4, 2002 public meeting, the Chevy Chase Advisory Neighborhood Commission (ANC 3/4G) voted 4 to 2 (a quorum being 4) to request a **CONTINUANCE** of the above-referenced application in order for the community to review and comment on Stonebridge Associates' (developer) third version of Case No. 02-17 filed with the Zoning Commission on October 25, 2002.

ANC 3/4G scheduled Stonebridge Associates for a presentation of its case on October 28, 2002, assuming that the developer would present the second rendition of its plans, as reflected in the Office of Zoning's undated "Revised Notice of Public Hearing." We learned on Sunday, October 27th, from a member of the community, that a third version of Case No. 02-17 had been filed with the Office of Zoning on Friday, October 25th.

Given the abbreviated period in which ANC 3/4G must hear, assimilate, discuss, weigh, write, review, and assemble its response in time for a November 14th Zoning Commission hearing, ANC 3/4G respectfully petitions the Zoning Commission to **CONTINUE** the case to allow adequate time for elected community representatives and other interested parties to respond.
