Citizens who comprise the community of the LaMond Riggs Subdivision (collectively referred to herein as the "Citizens") hereby submit to the District of Columbia Zoning Commission via the Zoning Office two hundred seventy-two (272) adult signed petitions of opposition to the zoning application by the West Group Development Company and the Jarvis Company for the rezoning of the property located at 6000 New Hampshire Ave., NE, Washington, DC 20011, from **R-1-B** to R-5-B, hereby referred to as Case #05-30.

On Friday, September 16<sup>th</sup> the Citizens requested from the Zoning Office a case number and was told that no number had been assigned yet, but to call back on Monday because the number would be assigned no later than Wednesday. The Citizens called on Monday as a follow-up. The Citizens received a case number for this matter from the Zoning Office via telephone on Tuesday, September 20, 2005, the date on which the case number is believed to have been assigned.
