It has come to my attention that a letter "written" by Judi Jones commissioner for 4B07 and signed by the vice chair of our commission Blondine Hughes was signed on my behalf as the chair. This was not done on my behalf nor approved by me the chair of the commission, nor does anyone but our secretary or I the chair have the write to send out any official documents on behalf of the ANC.

I did not sign this letter nor did our secretary Sara Green of 4B commission write the letter because we are "NOT" designating Judi Jones as the representative to speak on behalf of the 4B Commission.

Judi Jones has refused to read the resolution and stick to the facts of the vote by the entire 4B commission. Ms. Jones wants to give you her own "personal" report and not one that has been voted on or approved by the 4B Commission. She feels she wants more time to speak and this will be her avenue to do so.

After the July 20th meeting Ms. Jones asked if she could be the rep for the commission at the September 7th hearing and the vote was 4-0-5. But since Ms. Jones has repeatedly even after being told at our Public meeting by several commissioners in the public meeting that she can only present to the zoning commission what the ANC commission has agreed to and voted on, but she refuses to do just that.....she has continued to say that she is writing her "own" report, she has told residents this, and even announced that she will present zoning with "her" report at her single member district meeting last week in which myself and another commissioner were present.

The community leaders including myself and Commissioner Bowser have been meeting and working with The West Group to iron out a few problems we heard from you and your fellow commissioners, and to work out some of the community concerns as well so that this development will please as many as possible.

The Lamond Riggs Citizens Assoc, Citizens Aware, Lamond Community Action Group, myself and Commissioner Bowser have attended all of the small group meetings and **Judi Jones has refused to attend the meetings** which groups for and against the development have spent 3 hours or more each meeting working out details and working with the developer to try and make everyone as happy as we possibly can.

For these reasons and more the 4B commission will be holding a special meeting on August 31, 2006 because the majority feels it will be better to allow me to continue to represent the commission in a fair manner and present only the facts to the zoning commissioner and not personal attacks.
