Cherita:  
Judi Jones and I have had two telephone calls in the past two days about a letter to the Zoning Commission on the Med-Star property issue. We also discussed a special meeting to be held, tentatively, on August 24 on the same topic.

1. Judi tells me there is a problem getting an ANC 4B letter to the Zoning Commission. That letter is needed to notify them that Judi Jones, ANC 4B07,

is designated to speak on behalf of ANC 4B on the Med-Star property PUD.

As you know, our ANC voted to designate Judi as the rep during our July public meeting.

Has Judi misunderstood? Will you sign this letter as chair?

As you also know, the Zoning Commission rules require that the ANC Chair or Vice Chair send such a letter seven days before the hearing, set for September. (I have confirmed this rule with Gottlieb Simon.)

Blondine could do this as VP, but I hope you can clear this up.

2. I agreed, at Judi's request, to sign a letter calling for a special meeting to be held on August 24 on the Med-Star PUD. Only three signatures are needed, as you know.

However, I told Judi that the purpose of the meeting needs to be clearly stated in the letter. I want to review the reports from the Office of Planning and the Department of Transportation and I want to question the staff from these agencies and give residents a chance to question staff.

This is what your letter to the Zoning Commission said and I hope
