Dear ANC Chairs & ANC/SMD Commissioners:

Pursuant to D.C. Official Code § 1-309.10(b), the Zoning Commission for the District of Columbia hereby gives you notice of the receipt of an application from the above Applicant for approval of a 2<sup>nd</sup>-stage PUD and modification of significance to the 1<sup>st</sup>-stage PUD to property located in the northeast quadrant of the District known as Square 3765, Lots 1-4 and 7-9 and Square 3767, Lots 3-4. Please note that this case was filed electronically through the Interactive Zoning Information System (“IZIS”). You can access and file your report for this case through IZIS at <https://app.dcoz.dc.gov>.

Pursuant to Subtitle Z § 400.7, the ANC has the opportunity to file the attached Form 130 – ANC Setdown Report to provide feedback on whether or not the Zoning Commission should set down the case for public hearing. You have 30 days to file the ANC Setdown Form from the date the application was referred (Subtitle Z § 400.8).

Further, you will also receive notice of the hearing date at least 40 calendar days in advance. Pursuant to Subtitle Z § 406.3, if your ANC wishes to participate in the hearing, then its written report must be received at least seven days in advance of the public hearing. The report must contain the information required by Subtitle Z § 406.2, which is included at the bottom of this letter. That information is also included in Form 129 – Advisory Neighborhood Commission (ANC) Report, which is attached for your convenience and is the preferred mechanism to complete your report. Any written report received prior to the date of a Commission meeting to consider final action will be given “great weight.”

Pursuant to D.C. Official Code § 1-309.10(d)(2), the Zoning Commission must wait 30 days, excluding Saturdays, Sundays, and holidays before it can make its decision on this application. However, as a practical matter, the Commission cannot make a decision that soon, because it must first hold a public hearing and, for those cases that require proposed action to be taken, the National Capitol Planning Commission is thereafter given thirty days to review the application.

Great weight does not mean that the Zoning Commission must defer to an ANC’s view, but instead requires acknowledgement of the ANC as the source of the recommendations and explicit reference to each of the ANC’s issues and concerns. It is therefore important that the written report not only indicate

whether the ANC supports or opposes the application, but that it also identify each issue and concern that led to the recommendation made.

**Subtitle Z § 406.2**

- 406.2 The Commission shall give "great weight" to the written report of the ANC(s), pursuant to § 3 of the Comprehensive Advisory Neighborhood Commissions Reform Amendment Act of 2000, as amended, that is received at any time prior to the date of a Commission meeting to consider final action including any continuation thereof on the application. All written reports shall contain the following:
- (a) The case name and number;
  - (b) The date the public meeting of the ANC to consider the application occurred;
  - (c) A statement that proper notice of that public meeting was given by the ANC;
  - (d) The number of members of the ANC that constitute a quorum and the number of members present at the public meeting;
  - (e) The issues and concerns of the ANC about the application, as related to the standards against which the application shall be judged;
  - (f) The recommendation, if any, of the ANC as to the disposition of the application;
  - (g) The outcome of the vote on the motion to adopt the report to the Commission;
  - (h) The name of the person who is authorized by the ANC to present the report; and
  - (i) The signature of the ANC Chairperson or Vice-Chairperson.

**THIS CASE IS OF INTEREST TO ANCs 5A and 4B**

On September 4, 2018, the Office of Zoning received an application from The Morris & Gwendolyn Cafritz Foundation (the “Applicant”) for approval of a 2<sup>nd</sup>-stage planned unit development (“PUD”) and modification of significance of the 1<sup>st</sup>-stage PUD for the above-referenced property.

The property that is the subject of this application consists of approximately 5.18 acres, and is formally designated as Lots 1-4 and 7-9 in Square 3765 and Lots 3 and 4 in Square 3767, 4<sup>th</sup> Street, NE between Ingraham Street, NE and Kennedy Street, NE to be closed and a parallel 16-foot alley running between Kennedy Street, NE and Ingraham Street, NE to be closed (collectively, “Block B”). Block B is currently occupied by low-rise multi-family residential apartment buildings that are part of the Riggs Plaza Apartment complex and is bounded by South Dakota Avenue, NE to the east, Kennedy Street, NE to the north and Ingraham Street, NE to the south, and a 20-foot alley to the west.

The Applicant proposes to redevelop Block B with an apartment building containing approximately 210-250 units and 192, 287 square feet of 192,287 square feet of GFA of residential space, as well as common amenity space, and ground floor retail space (the “Residential Building”) located on the west side of the closed 4<sup>th</sup> Street, NE. The portion of Block B that is bound by South Dakota Avenue, NE, Ingraham Street, NE, Kennedy Street, NE and the closed 4<sup>th</sup> Street, NE will be developed with a structure that includes approximately 30 units of artists housing and work space, as well as associated common amenity space (the “Artist Housing”), a ground level grocery store (the “Grocery Store”), ground floor retail space, a children’s museum containing approximately 24,931 square feet of GFA, space for cultural uses and a family entertainment zone comprising approximately 152,162 square feet of GFA, and approximately 765 parking spaces (collectively, the Project”). The overall GFA for Block B is 491, 777 square feet and the overall FAR for Block B is 2.34. This application also provides a detailed phasing plan for the development of the remaining parcels of APFT, Blocks C and D.
