Dear Board Members,

At its regularly scheduled and properly noticed meeting on April 10, 2007, with a quorum present, ANC 6B voted unanimously (10-0) to support the proposed text amendment with the understanding that the Commission believes that further analysis of §733 of the Zoning Regulations is needed before the proposal is approved. That ANC recommends that the current criteria under §733 be made discretionary to BZA as part of the special exception and that the criteria for the number of seats be increased from 12 to 18 for prepared food shops in order to eliminate several shortfalls. Additionally, we request the Commission to please waive the 10-day prior notice on this case.
