14th Street & Spring Road, NW

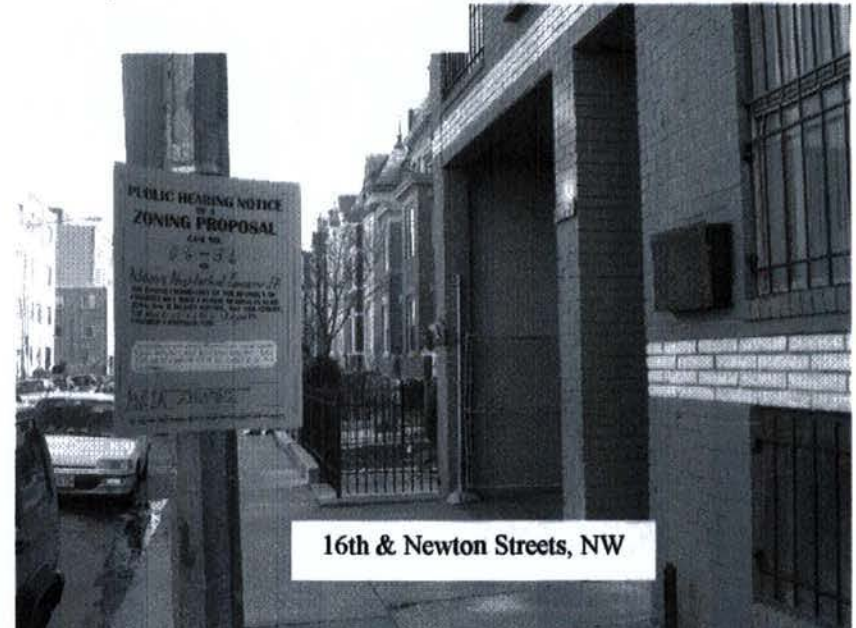


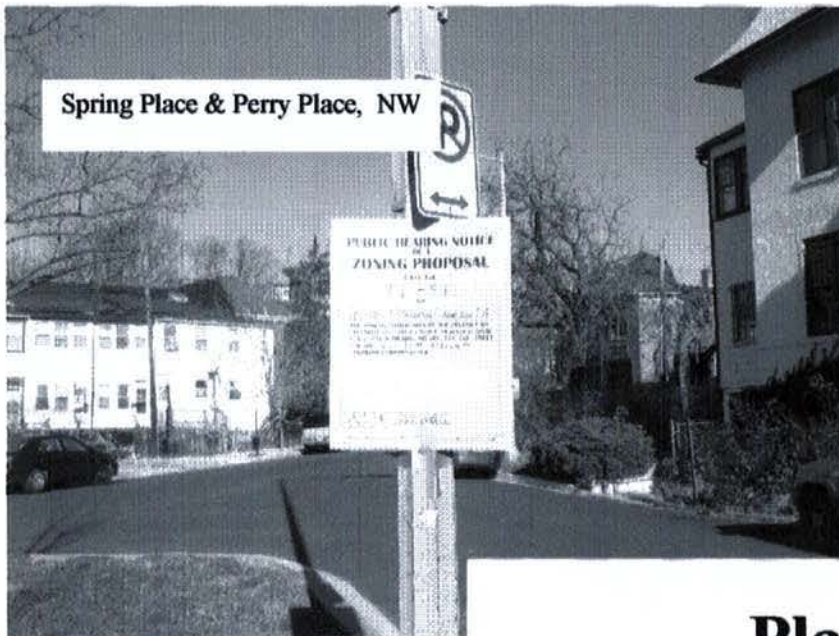

16th & Monroe Streets, NW

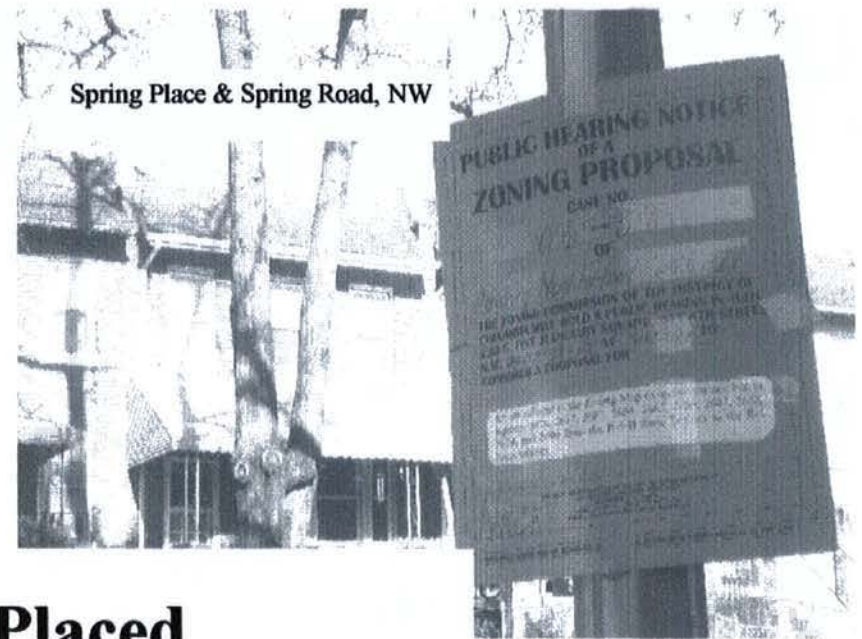


16th & Newton Streets, NW



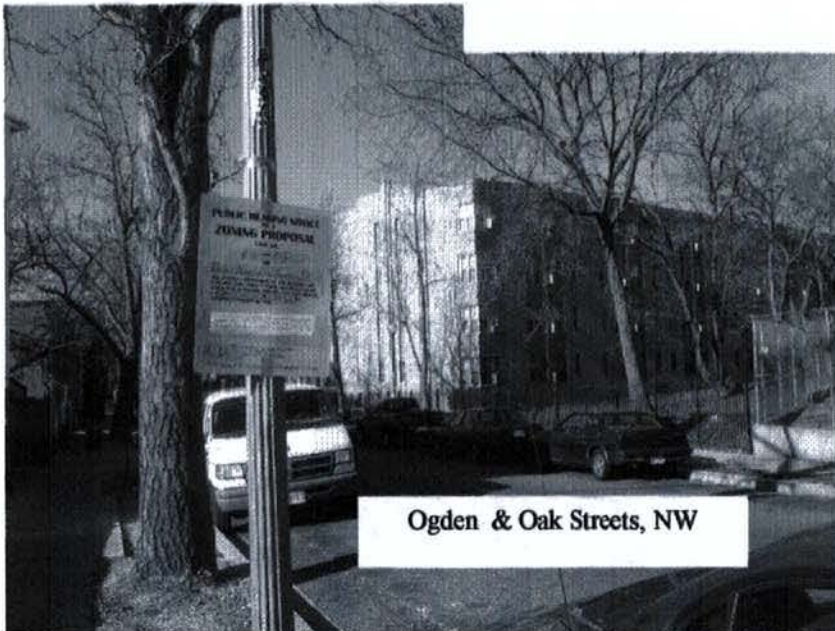


Spring Place & Perry Place, NW

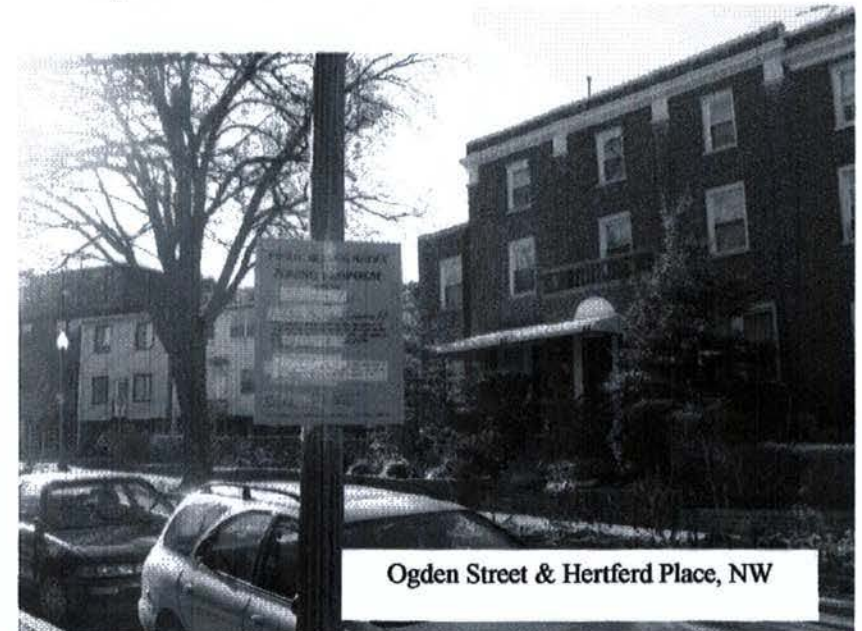


Spring Place & Spring Road, NW

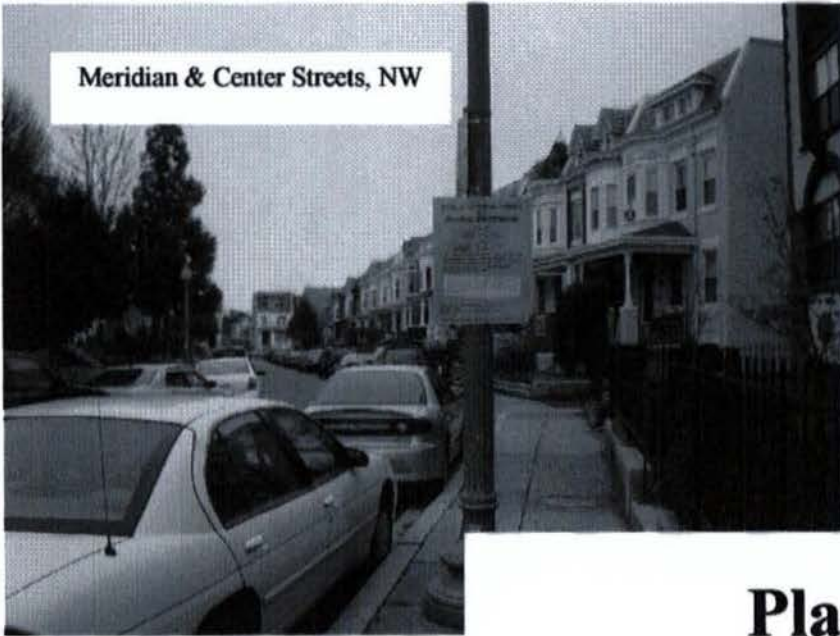


Ogden & Oak Streets, NW

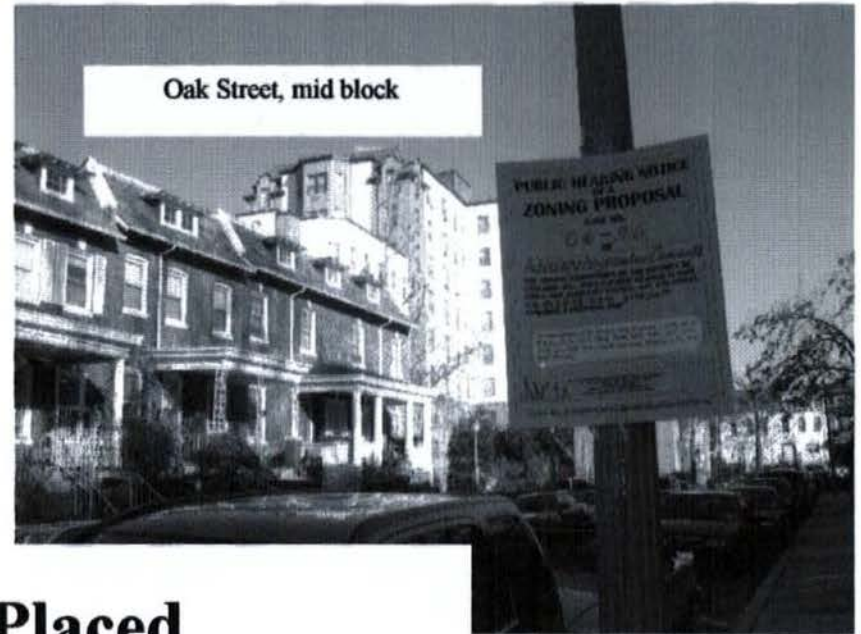


Ogden Street & Hertford Place, NW

Oak Street, mid block



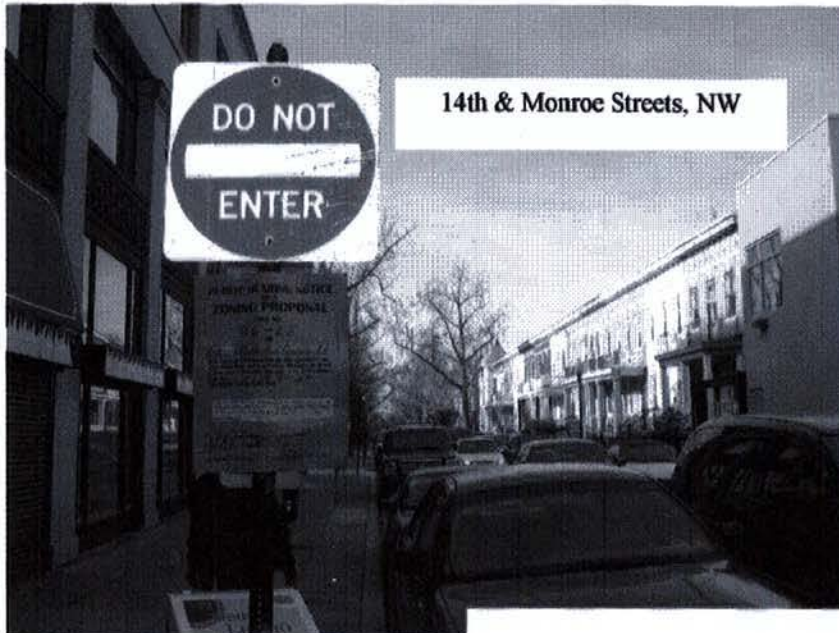

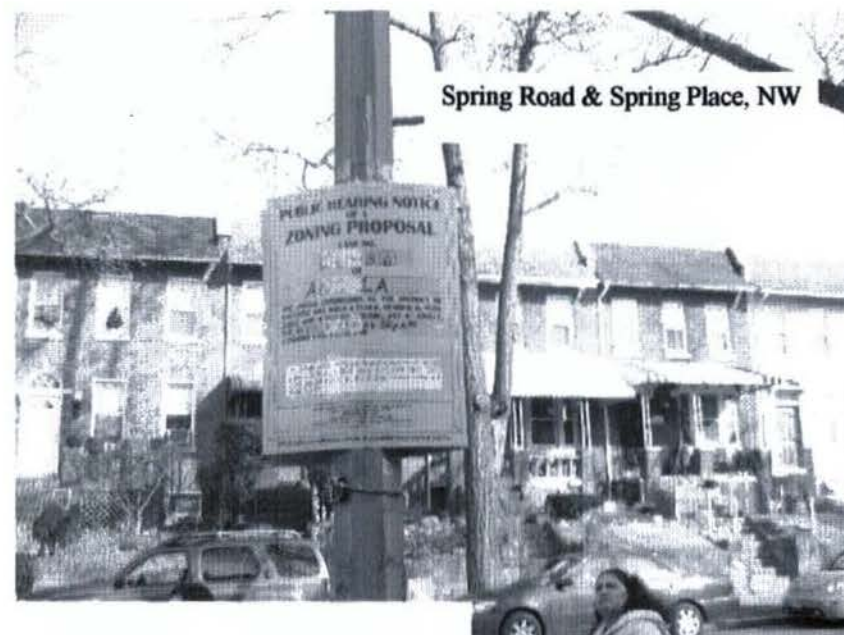
Oak Street, mid block

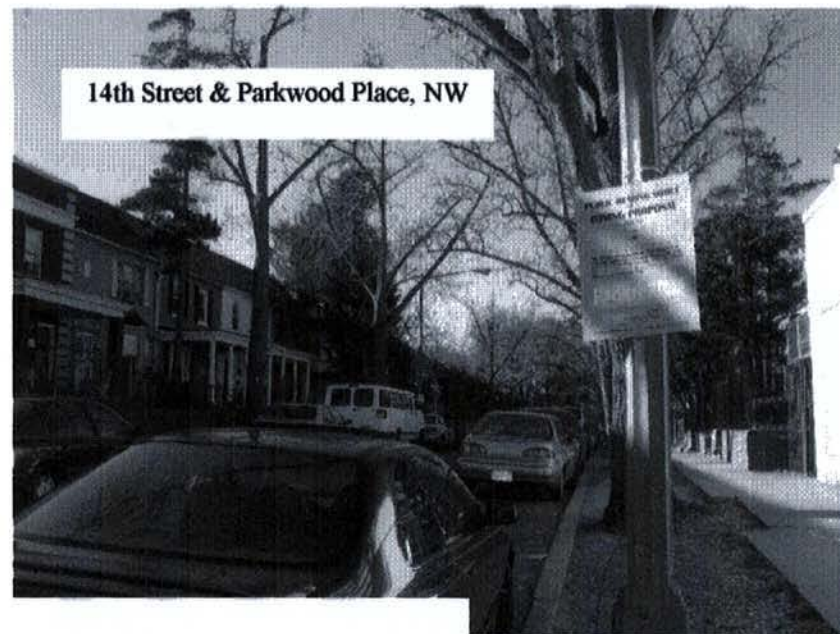
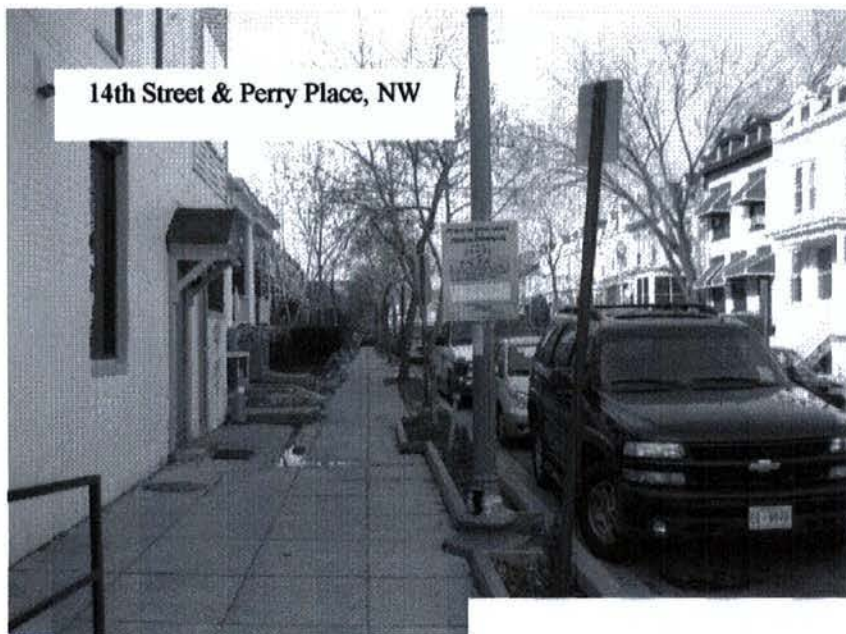
January 7, 2007 Placards Replaced

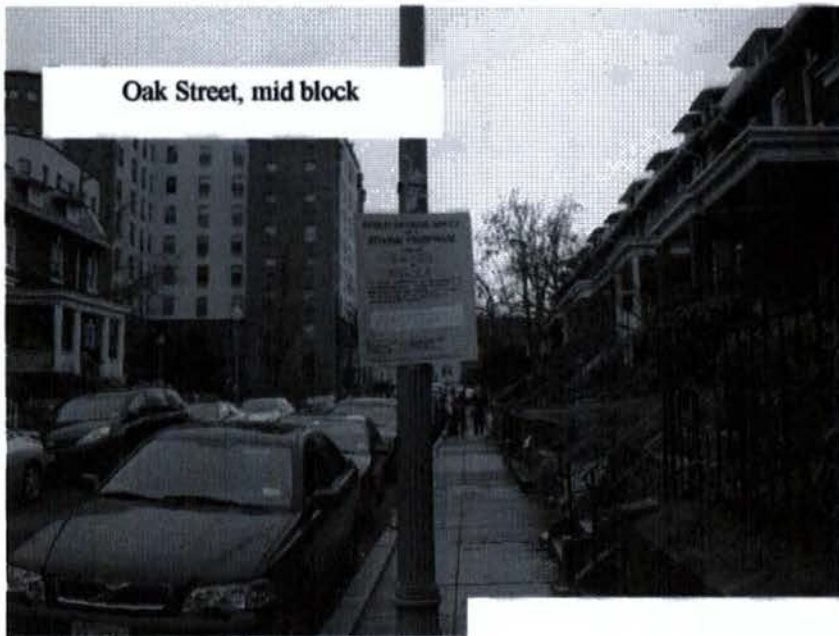


14th Street & Parkwood Place, NW

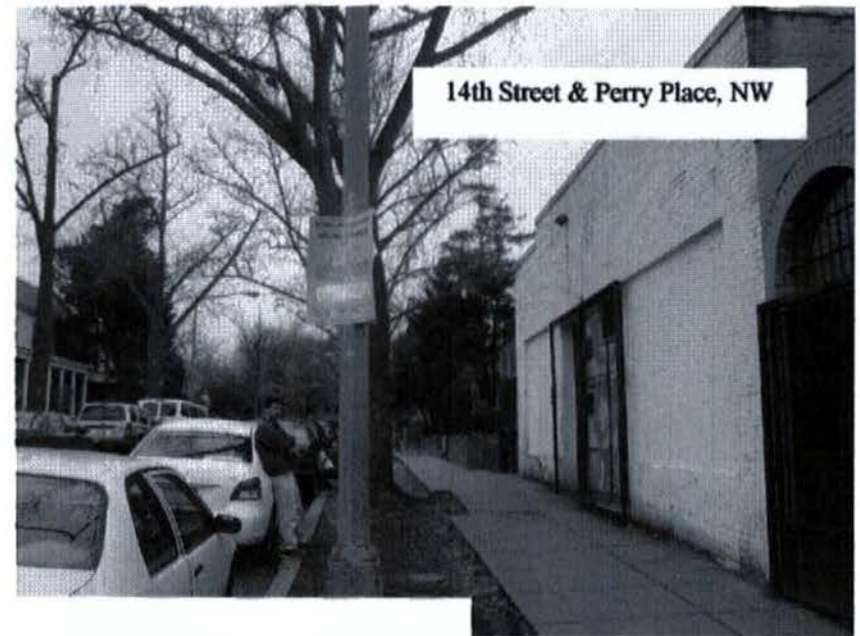

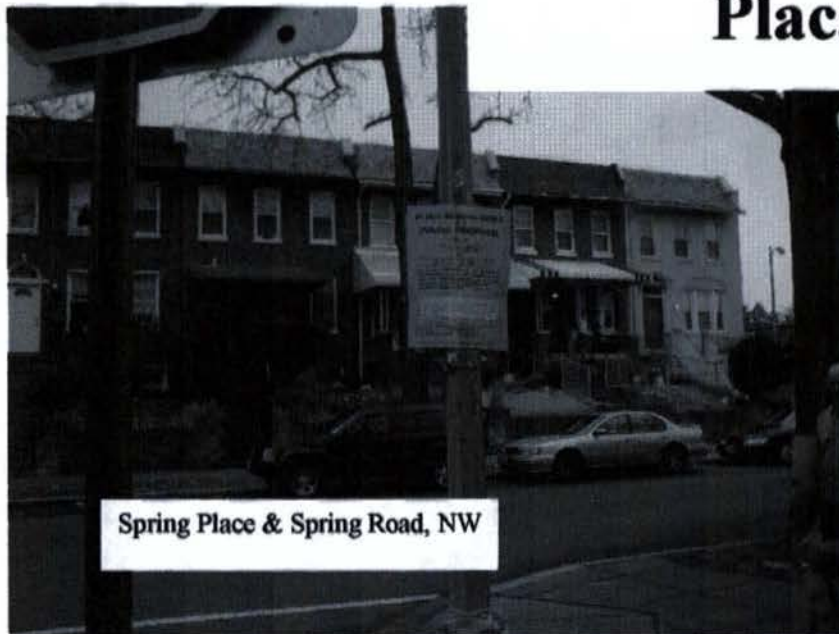


Oak Street, mid block

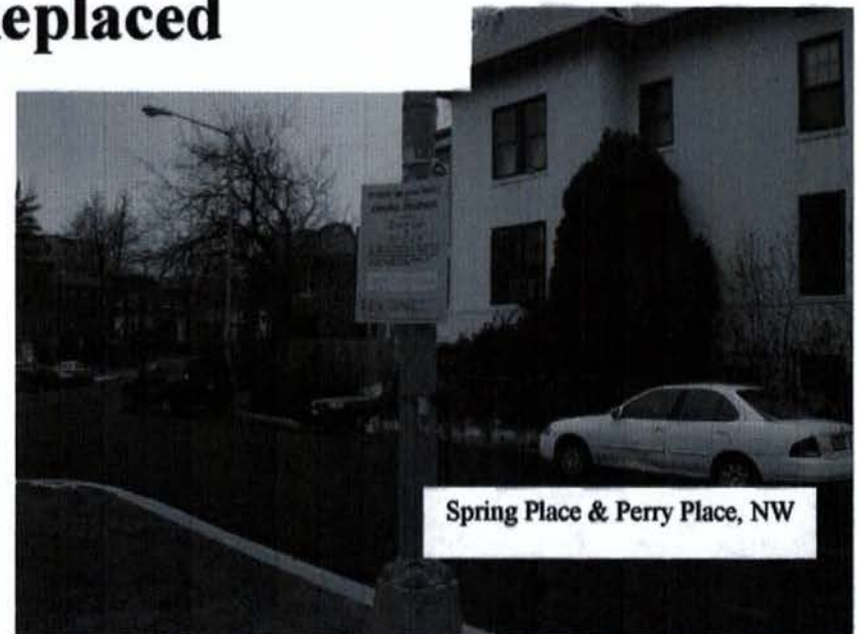


14th Street & Perry Place, NW

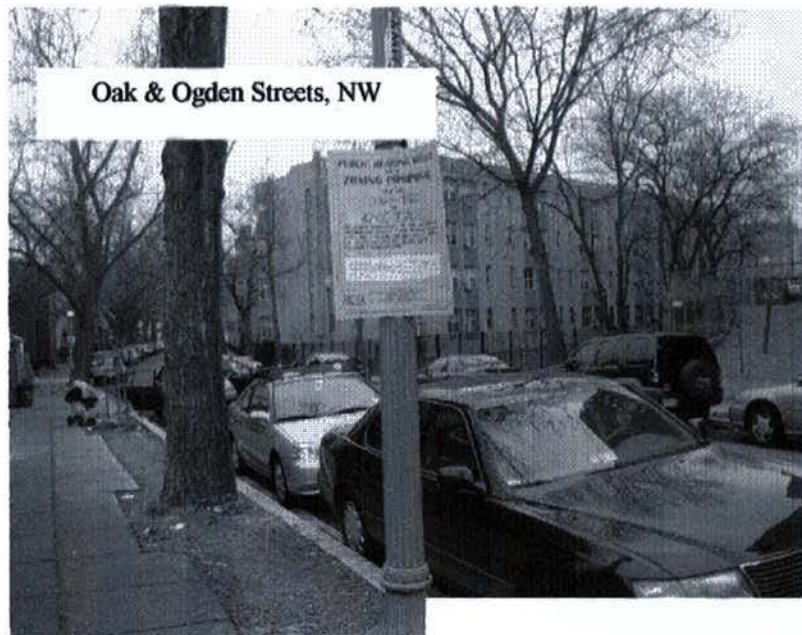
January 14, 2007 Placards Replaced



Spring Place & Spring Road, NW

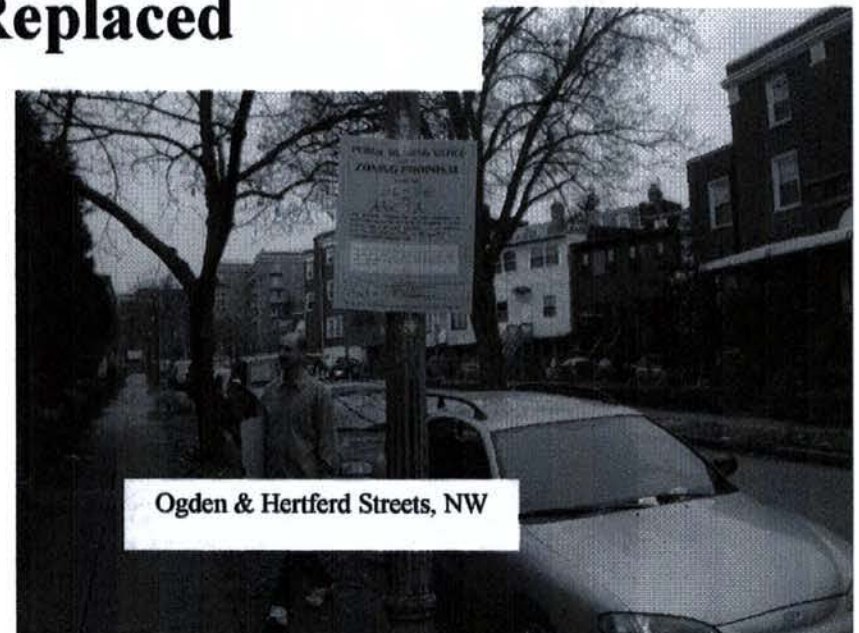

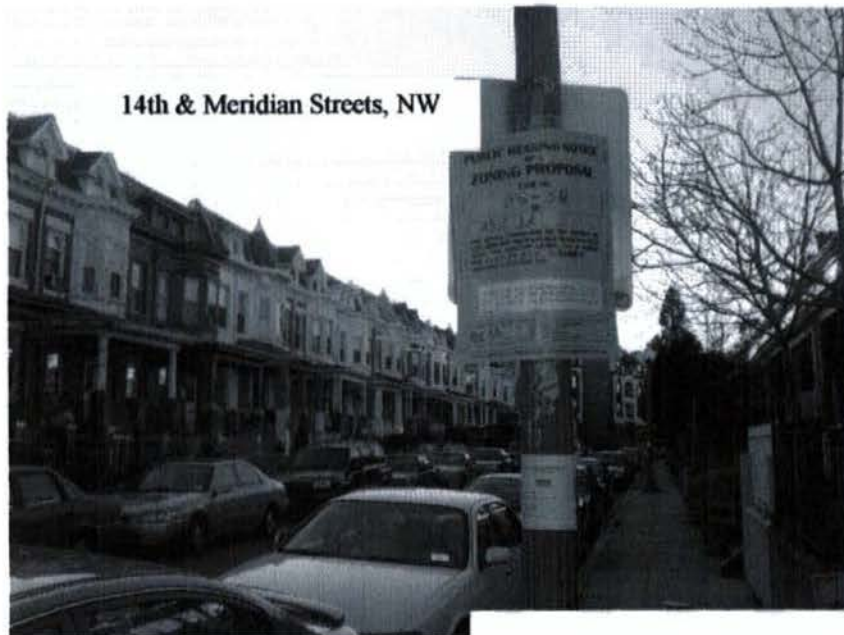


Oak & Ogden Streets, NW

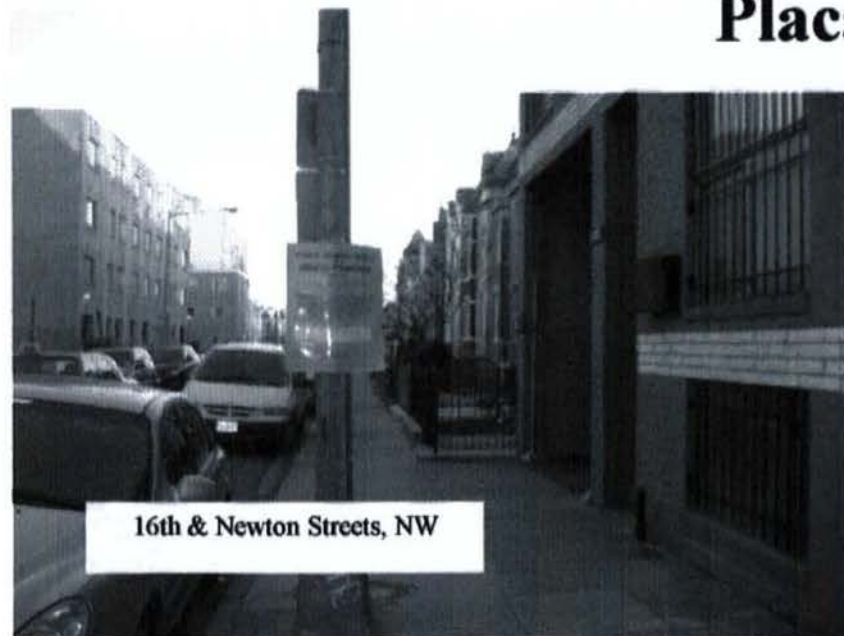

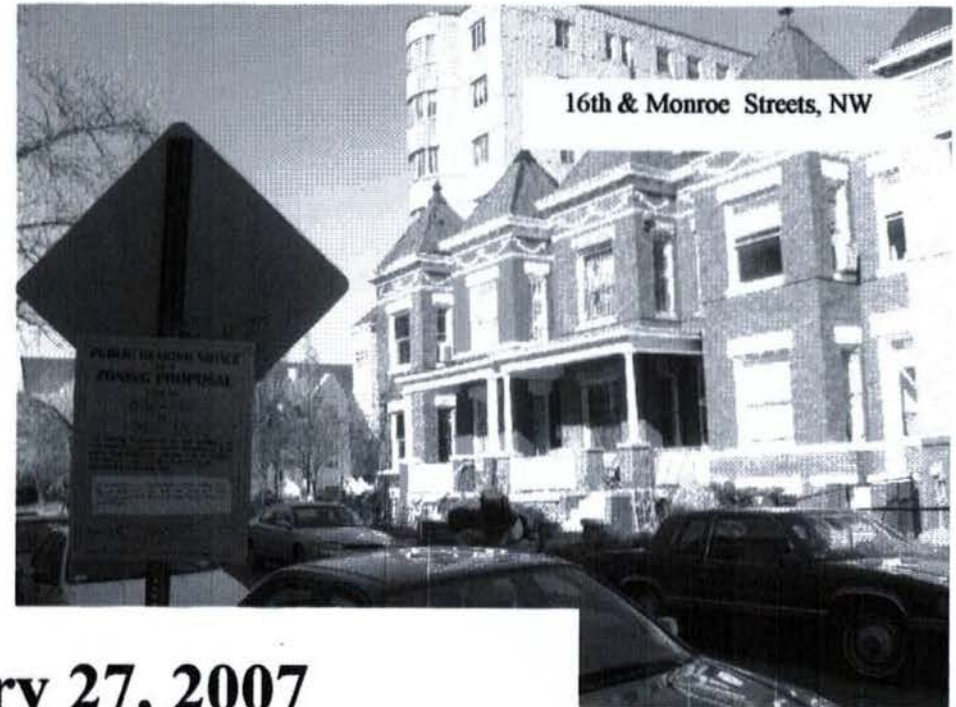


Ogden & Hertferd Streets, NW

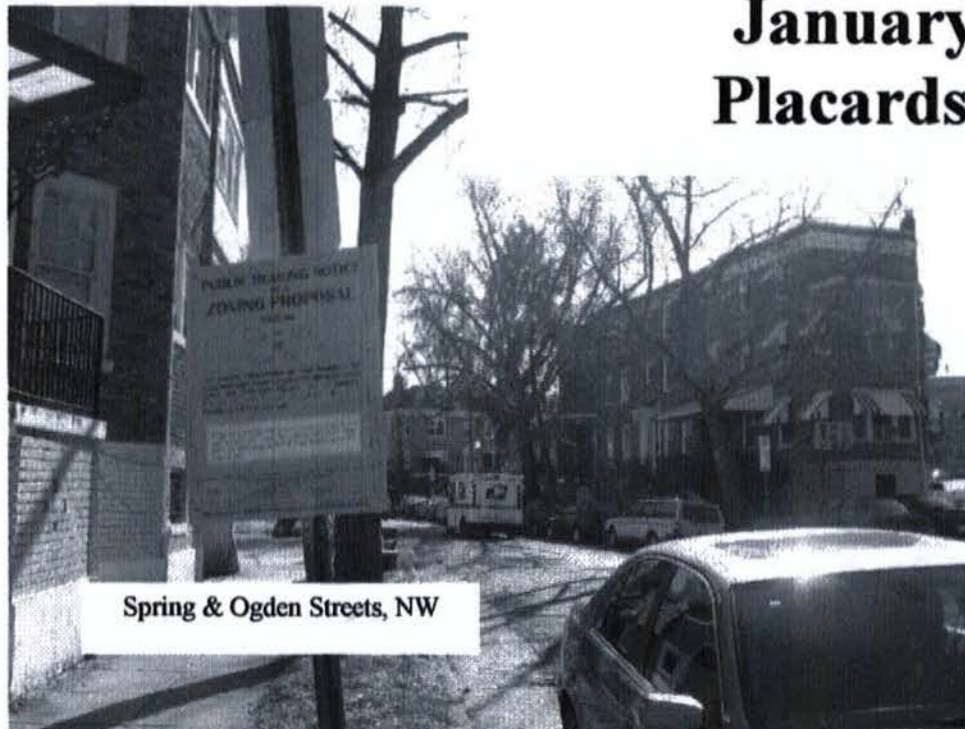


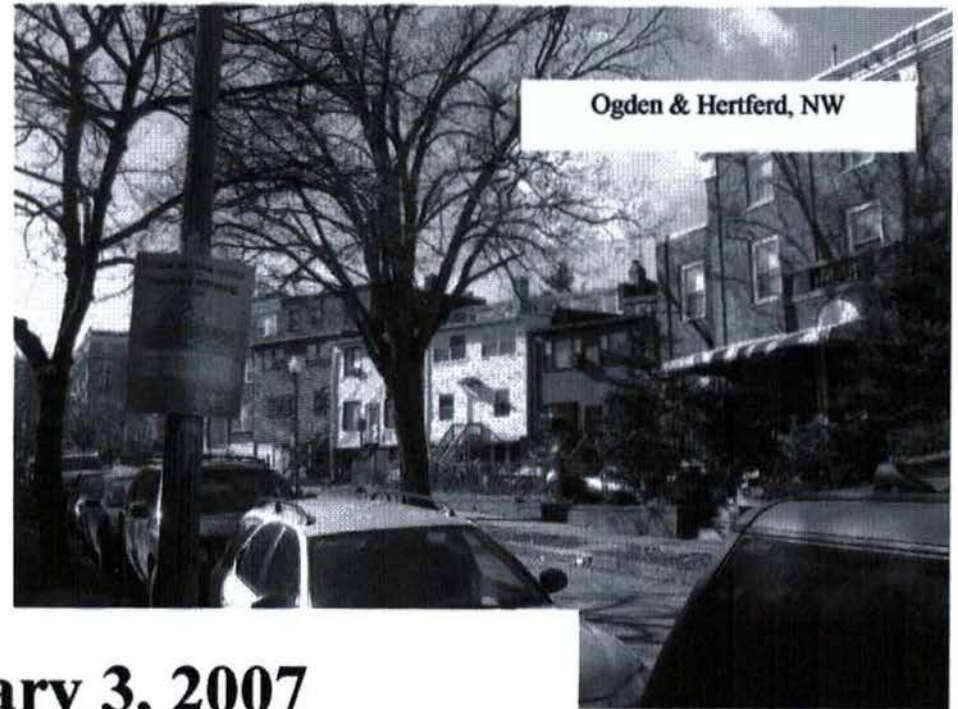

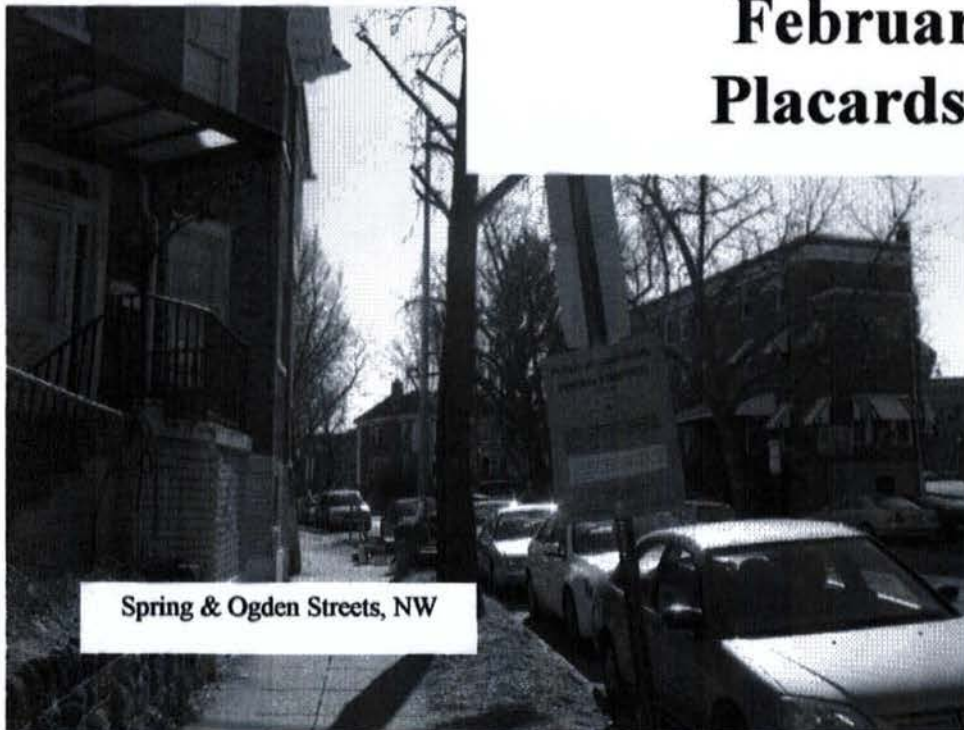
