I hereby affirm that placards for Zoning Case 06-36A, having been originally posted (according to previous affidavit) on March 10, 2007, have been maintained since that date on a weekly basis. On March 17th, all placards needed to be replaced, due to a recent storm that included freezing rain, sleet, and high winds. On March 24th, all placards were still in place, and no new ones were posted. On March 31st, all placards were still in place, and no new ones were posted. On April 7th, one placard was replaced at the corner of 16th & Monroe Streets, NW. All others were still in place, and no new ones were posted in those locations. 

On April 27th, 2007, the placard on Center Street at Oak Street, NW was replaced. A photo is attached.












Center Street at Oak Street, NW
