## **RIVERFRONT PERKS PROGRAM**

### **Program Overview**

- Riverfront Perks Program is only available at Camden South Capitol and cannot be redeemed at any other Camden apartment community.
- Residents living within the jurisdiction of ANC 6D must present the Camden Riverfront Perks Coupon on or before move-in. The applicant must be a lease holder to receive the benefit.
- The \$250 benefit may be applied to move-in fees, including application, or guarantor fee. Benefit may not be applied to rent or deposits. If total move-in fees equal less than \$250, the remaining balance is forfeited.
- Fees that are due at the time of leasing the apartment are paid up front, and benefit will be credited upon.
- Only one Riverfront Perks Coupon benefit may be used per apartment.
- Residents of ANC 6D are eligible for community specials that are not a duplication of the Riverfront Neighbors' Perks Program.
- If cancellation of a lease occurs, all cancellation policies apply.
- If an applicant is not approved for rental, all application policies apply.
- If the applicant defaults on his/her lease, all benefits are automatically void, and all credited fees will be due immediately.
- Camden will publish the program to the residents of ANC 6D through Outreach marketing, community newsletter and social media.
