

LOT 57

Being a portion of Lot 57, Square 3848, recorded in Book 198 at Page 150 among the records of the Office of the Surveyor for the District of Columbia, and being more particularly described as follows:

Beginning for the same at a point marking the westerly end of the North 68° 26' 00" East, 27.58 foot plat line of Lot 57, said point also lying on the southerly line of Rhode Island Avenue, N.E.; thence running with said plat line and with said Southerly line of Rhode Island Avenue, N.E.,

- 1.) North 68° 26' 00" East, 27.58 feet to a point; thence leaving said southerly line of Rhode Island Avenue, N.E., and running with the outline of said Lot 57, the following four (4) courses and distances:
 - 2.) South 21° 34' 00" East, 58.40 feet to a point; thence
 - 3.) South 08° 43' 00" West, 16.50 feet to a point; thence
 - 4.) South 81° 17' 00" East, 147.50 feet to a point; thence
 - 5.) South 08° 43' 00" West, 94.89 feet to a point; thence running so as to cross and include a portion of said Lot 57, the following four (4) courses and distances
- 6.) 60.51 feet along the arc of a non-tangent curve to the left having a radius of 61.89 feet and a chord bearing and distance of South 71° 59' 41" West, 58.13 feet to a point; thence
- 7.) South 41° 26' 34" West, 79.24 feet to a point; thence
- 8.) North 69° 42' 50" West, 18.59 feet to a point; thence

9.) 28.26 feet along the arc of a non-tangent curve to the right having a radius of 29.01 feet and a chord bearing and distance of North 31° 23' 44" West, 27.15 feet to a point marking the outline of said Lot 57; thence running with a portion of said outline of Lot 57, the following three (3) courses and distances

10.) 153.26 feet along the arc of a non-tangent curve to the left having a radius of 251.66 feet and a chord bearing and distance of North 05° 37' 41" West, 151.43 feet to a point; thence

11.) North 20° 31' 40" West, 57.38 feet to the point; thence

12.) North 05° 05' 04" West, 20.03 feet to the point of beginning containing 22,961 square feet or 0.52711 acres of land.
