THIS CASE IS OF INTEREST TO ANC 2C

On September 17, 2007, the Office of Zoning received an application from O Street Roadside, LLC (the "applicant") for approval of a planned unit development and related map amendment for the above-referenced property.

The property that is the subject of this application consists of Square 398, Lots 829 and 830 in Northwest Washington, D.C. (Ward 2) with an address of 1400 7th Street, N.W. The property is currently zoned C-2-A.

The applicant proposes an amendment to the zoning map to the CR, or C-3-C in the alternative, Zone District in order to build a new mixed-use residential, commercial, and retail development consisting of approximately 870,000 square feet of gross floor area. The total density for the project is 5.35 FAR and the buildings will have a maximum height of 110 feet.
