Re: Case No. 08-07A, Submission of Four Points LLC regarding Stage II Planned Unit Development at 2255 Martin Luther King Ave, SE

Dear Chairperson Hood & Members of the Board,

I am writing to express my enthusiastic support for the application above to redevelop a vacant, under-utilized, surface parking lot into a 71-unit mixed income residential building. As a member of the community, and a design professional within the field of architecture and urban design, I believe the project would be a wonderful addition to the languishing main street. The proposal helps to activate Martin Luther King Boulevard and Chicago Street and adds much needed density and a mix of uses. These uses will complement other proposals within the PUD application ultimately resulting in a more vibrant 24-hour community, providing and supporting amenities that our community currently lacks.

The proposal's intent to provide artist walk-up studios is an effective way in creating "defensible space", promoting surveillance along Martin Luther King Boulevard, and creating eyes on the street. These techniques have been demonstrated to increase safety. Any concerns of loitering are largely unfounded. Targeting the ground level units to artists are also a creative way of infilling the street front with small artist studio's where it has clearly been demonstrated that retail demand is low. Revitalization of Anacostia through the arts is a proven successful and recurring strategy in the area; which include fixtures such as the Anacostia Arts center, the Anacostia Playhouse, Honfleur Gallery, and Kraft Studios. Such a project can help Anacostia become a premier artist district with the District of Columbia.

It should not be under-scored of the importance in providing much needed affordable housing within the District—the need for which served as the basis for the Mayor's agent's recent decision in allowing the historic houses adjacent to the site to be relocated. Four Points LLC's plans to work with Teach for America and other community organizations to target the housing to teachers and artist is truly commendable. A similar project your board approved, PUD application 08-08; at 3910-3912 Georgia Ave NW should be noted. I previously resided at the mixed-income project which is also near a metro, along a main street, with a non-traditional use at the ground floor. This project was critical in providing affordable housing for me to live as an aspiring architect. It also provided a foundation which I could successfully transition out of, and enabled me to purchase my first home in Anacostia. It also highlights an interesting case study of the area around Georgia Ave/Petworth. Here the mix-income project provided a community serving clinic at ground level in an area with low retail demand at the time, while simultaneously helping

revitalize the main street. Now it helps to preserve affordably in an area where subsequent projects, are rapidly changing the area. It is with such foresight that we must approach this project.

Many areas around the city also demonstrate how taller building can co-exist harmoniously with buildings of a lower scale. The topography of the land also rises steeply after crossing Martin Luther King Boulevard, heading southward. This places many of the buildings in the adjacent district at a notably higher elevation than the proposal. It must also be pointed out that this project is not within the historic district and thus is not subject to any of the secretary of interior's standards on historic preservation, nor any group's opinion of what historic preservation should be. What the proposal does achieve, through its use of materials, and concatenation of forms, is a breaking down the massing and scale of the proposal. It also successfully pays respect to the adjacent historic district, and DC's row house vernacular, in a contemporary way.

I have attached my resume providing additional details about my background. I cannot reiterate my full support—as well as that of the majority of the community—for this project. This development positively and meaningfully helps to create a sense of place along Martin Luther King and in-fills an area of the main street currently plagued by a large expanse of lifeless surface parking.
