THIS CASE IS OF INTEREST TO ANC 4C

On April 15, 2008, the Office of Zoning received a petition from ANC 4C (the "Petitioner") for approval of a text amendment to the Sixteenth Street Heights (SSH) Overlay District and a Zoning Map amendment from the R-1-B Zone District to the SSH/R-1-B Zone District for Squares 2708-2716.

The properties that are the subject of this petition are located in Northwest Washington, D.C. (Ward 4) and are bounded by Colorado Avenue (north), Decatur Street (south), 13th Street (east), and 16th Street (west).

The Petitioner proposes a related text amendment to extend coverage of the Sixteenth Street Heights (SSH) Overlay District to the above-referenced properties so as to prevent further conversions of residential uses to non-residential uses.
