If you would like to place an item on the agenda, please call me or work through your Single-Member District Commissioner. (There are ten commissioners serving on ANC 4C.)

Tonight's meeting will end around 8:30-8:45 pm. Next month's meeting is scheduled for Tuesday, February 12, 2008, same starting time and location.

We routinely invite the Metropolitan Police and representatives from Fire/EMS to provide an update on local, public safety issues.

Anyone from the community is welcome to speak for up to three minutes about any neighborhood concern. The Community Comment period usually falls around 7:00-7:15 pm.

**Neighbors from SMD 4C02, represented by Commissioner Damian Nickens, are expected to talk about the proposed, expansion of the Church of Latter Day Saints at 4901 16th Street NW and ask for ANC support in the residents' efforts to oppose the planned expansion.**

**Subject:** Meeting tonight on 16th and Emerson - Issues to discuss

Hello Neighbors,

I just want to make sure that the concerns we have will be addressed in this meeting tonight at 6:30.

Some of the items you have expressed in no special order are:

1. Whether or not the Mormons circumvented the system by razing the building on that property. Should it not have been done differently? and where was the community input. It is my understand that this was one of the oldest buildings in the area (can we corroborate that?) Did they go through due process.
2. If they have a congregation of 250 or more and are having only 79 or so parking spaces, where will the other cars park?
3. What percentage of the mature trees on the lot will be cut down. Can it be avoided?
4. How often do they meet on Sundays and during the week?

5. What is their responsibility to the neighborhood in terms of notifying and what weight the ANC commission has in these things. It is our understand that there is to be great weight given to ANC concerns.
6. What segment of the community are they obligated to or ethically expected to notify. 2 block radius? or what? and by what means?
7. Do they welcome the community to their facility?
8. Are the looking to acquire 1500 Farragut? Are they aware it is for sale?
9. Are they leveling the property to street level? Will there be a fence around it? Will there be park land or green accessible and available to the community:
10. What is their responsibility for our property should there be damage, once they start to excavate for the underground parking?
11. Are there plans to reconfigure the traffic patterns at Piney Branch and Emerson, and at 16th and Farragut to accommodate traffic.
- 11 This should have been first - We really don't have anything against the Mormons, but we are overrun with large facilities here, as Denise listed in an earlier e-mail:

16th and Decatur (2)  
14th and Emerson  
14th and Gallatin  
16th and Bladgen  
Gallatin and Piney Branch  
14th and Farragut  
16th and Gallatin  
Piney Branch and Ingraham

#### Schools

16th and Decatur - British School  
16th and Blagden - Parkmont  
14th between Gallatin and Emerson - Kingsbury

We also have the Carter Barron, the Tennis stadium and for pollution saturation, the bus barn at 14th between Buchanan and Decatur

We have more than our share. The city should evaluate the footprint this facility will leave on the community.

We are also experiencing out of state cars parking all day in this neighborhood daily while they walk to 14th or 16th and catch the bus to work.

If you have other issues, please send to the entire list. We hope to have everything covered when we meet.

I won't be there tonight, but I know I will be represented by you.
