ZONING COMMISSION FOR THE DISTRICT OF COLUMBIA NOTICE OF PROPOSED RULEMAKING

Z.C. Case No. 08-09

(Text and Map Amendment – 11 DCMR) Expansion of the Sixteenth Street Heights Overlay District

The Zoning Commission for the District of Columbia, pursuant to its authority under § 1 of the Zoning Act of 1938, approved June 20, 1938 (52 Stat. 797, as amended; D.C. Official Code § 6-641.01), hereby gives notice of its intent to amend § 1551.2 of the Zoning Regulations (Title 11 DCMR) as well as the Zoning Map incorporated within the Zoning Regulations.

The proposed map amendment and text amendment would expand the existing Sixteen Street Heights Overlay District to include additional area to the south, making Decatur Street the new southern boundary.

Final rulemaking action shall be taken in not less than thirty (30) days from the date of publication of this notice in the D.C. Register.

The following rulemaking action is proposed (new text is shown bolded and underlined):

A. The Zoning Map is amended as shown in the following table:

Squares	Zone District
2708 through 2716	R-1-B to SSH/R-1-B

- B. Chapter 15, MISCELLANEOUS OVERLAY DISTRICTS, Section 1551, Sixteenth Street Heights Overlay District (SSH), § 1551.2, is amended to read as follows (new text is shown in **bold and underlined** text, deleted text is shown in strikethrough text):
 - The SSH Overlay District encompasses the geographic area in northwest Washington generally bounded by 16th Street and Rock Creek Park on the west, Military Road and Missouri Avenue on the north, and 14th Street on the east, and <u>Decatur Street on the south Colorado Avenue on the southeast</u>. This overlay zone is applied to properties zoned R-1-B in the following squares and portions of squares: <u>2708</u>, <u>2709</u>, <u>2710</u>, <u>2711</u>, <u>2712</u>, <u>2713</u>, <u>2714</u>, <u>2715</u>, <u>2716</u>, <u>2718</u>, 2719, 2720, 2720W, 2721, 2721W, 2722, 2722W, 2723, 2723W, 2724, 2724W, 2725, 2741, 2742, 2796, and 2799.

All persons desiring to comment on the subject matter of this proposed rulemaking action should file comments in writing no later than thirty (30) days after the date of publication of this notice in the D.C.
