(Center Place Holdings, LLC – 2nd-Stage PUD @ Square 568)

THIS CASE IS OF INTEREST TO ANC 6C

On June 4, 2012, the Office of Zoning received an application from Center Place Holdings, LLC (the “Applicant”) for approval of a second-stage planned unit development (“PUD”) for the above-referenced property.

The property that is the subject of this application consists of all of the land located in Square 568 (excluding Lot 43) and the air rights above I-395 Freeway in Square 568 in Northwest Washington, D.C. (Ward 6). This site is generally bounded by 2nd Street, N.W. (east), E Street, N.W. (south), 3rd Street, N.W. (west), and the extension of F Street N.W. (north).

This second-stage PUD approval is for an office building with ground-floor retail in the South Block of the overall PUD approved in Z.C. Order No. 08-34. This office building will contain approximately 693,587 square feet of gross floor area with a maximum height of 130 feet. The remaining improvements planned for the South Block, including relocation of the historic Adas Israel Synagogue and the proposed facilities for the Jewish Historical Society, will be part of a separate, subsequent second-stage PUD
