The adjacent neighbors of George Washington University's Mt. Vernon Campus called the "Neighborhood Alliance" filed a Request for Party Status Application dated December 10, 2009 in the above-captioned proceeding.

For the past number of months, the Neighborhood Alliance has been engaged in productive and fruitful discussions with officials from George Washington University ("GWU") regarding a number of issues of concern to the Neighborhood Alliance. In this regard, we have reached a compromise agreement with GWU and the primary issues of concern to us have been addressed and incorporated in GWU's pre-hearing filing. Accordingly, the Neighborhood Alliance no longer is opposed to GWU's Special Exemption or Approval of the New Campus Plan.

If granted by the Commission, the Neighborhood Alliance wishes to retain party status, but would only take a position in the proceeding in the event that are substantive modifications or amendments to GWU's pre-hearing filing which materially affect the Neighborhood Alliance.
