Chairman Hood and Members of the Zoning Commission:

This letter is to advise you that Advisory Neighborhood Commission 5D supports the application filed by Gallaudet University to amend its Campus Plan as part of its plans to renovate and repurpose the Merrill Learning Center building. The Gallaudet University campus is located within the boundaries of ANC 5D. The public hearing before the Zoning Commission is scheduled for January 27, 2025.

Gallaudet University representatives presented the Campus Plan amendment and Further Processing application to ANC 5D's Zoning and Development Committee at its meeting on September 19, 2024. The full ANC then considered the Application at its Committee of the Whole public meeting held on October 22, 2024. At its regularly scheduled and duly noticed meeting on November 12, 2024, with a quorum present, ANC 5D voted to recommend approval of the Application by the Zoning Commission.

ANC 5D supports Gallaudet's request to amend the University's Campus Plan to facilitate the sustainable redevelopment of the Merrill Learning Center in the heart of the campus. The University shared with ANC 5D the very poor condition of the building, which long served as the University's main library. The ANC learned that the University plans to relocate the library functions to a new building consistent with the approved Campus Plan and will return to the ANC to review plans for that building at a later date following a successful fundraising campaign. In the present Application, the University intends to demolish upper floor portions of the building while retaining the basement level and then construct a glass entrance level pavilion containing café and gathering space. The University plans to repurpose the Merrill Learning Center space for a deaf archives, various learning and production studios, formal and informal lecture/study spaces, and technology labs, all designed using DeafSpace design principles.

The proposed renovation project will minimize the amount of construction debris needed to be removed from the campus and will also serve to open up the sight lines across the University's historic Gallaudet Mall.

For these reasons, the members of ANC 5D voted unanimously to support Zoning Commission Application No. 12-15D. Thank you for giving great weight to the recommendation of ANC 5D on this matter.
