
Dear Chairman Hood,

Advisory Neighborhood Commission 5E submits this letter in response to Vision McMillan Partners (VMP) revised Planned Unit Development (PUD) materials filed on August 25, 2014.

On August 27, 2014, VMP convened a meeting with ANC 5E Commissioners to present an overview of its application revisions. VMP advised us of the reduced height of the medical office building, changes to the grocery store loading dock, the refinements to the community amenities and the construction phasing plan. VMP responded to ANC Commissioner's questions and provided handouts to be distributed to absent ANC Commissioners and constituents.

Vision McMillan's revisions are consistent with the ANC 5E June resolution of support for this PUD application.
