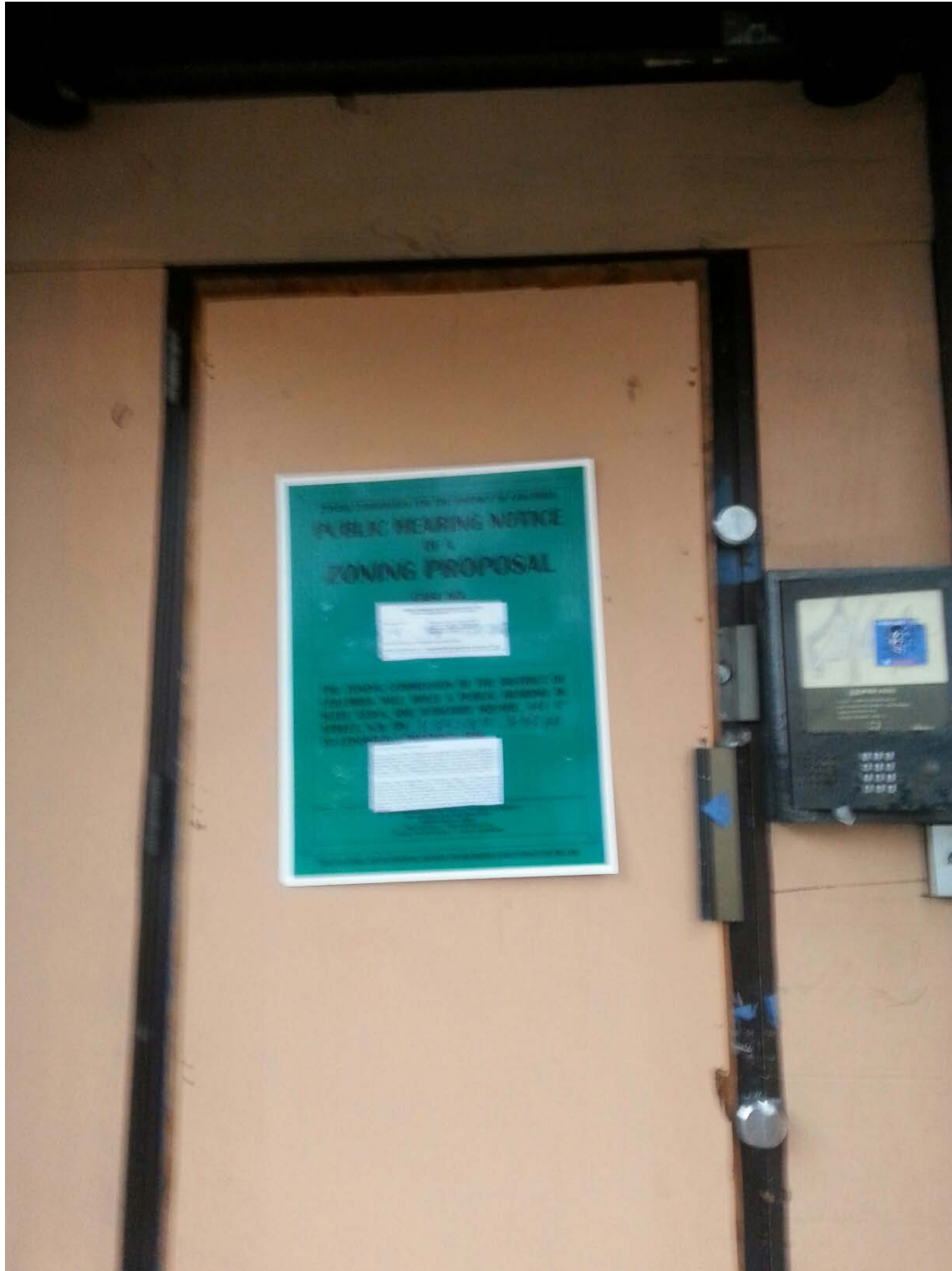

On June 17, 2014, the Office of Zoning received an application from ZC 369 LLC ("Applicant"), the current purchaser of Lots 40, 62, 65, 66, 67, 801, 802, 803, 804, 805, 828, 829, 842, 848, 859, and 878 in Square 369 (the "Property"), requesting approval of a planned unit development ("PUD") and related map amendment to rezone a majority of the Property from the DDC-2-A and DDC-3-C Zone Districts to the DDC-1-C Zone District. A portion of the Property fronting on 9th Street will remain in the DDC-2-A Zone District. The Office of Planning provided its report on July 18, 2014, and the case was set down for a public hearing on July 28, 2014. The Applicant provided its prehearing statement on August 7, 2014.

The Property consists of approximately 76,787 square feet of land area. The Property is currently improved with a surface parking lot and nine vacant historic buildings, seven of which will be incorporated into the new redevelopment project. The Applicant proposes to construct a mixed-use building on the Property comprised of residential uses and two hotels, a Courtyard by Marriott and a hotel that will contain approximately 368,951 square feet of gross floor area. The new building will be constructed to an overall maximum height of 110 feet and will contain approximately 368,951 square feet of gross floor area. Proposed uses will include approximately 222,027 square feet of gross floor area devoted to residential uses and approximately 146,924 square feet of gross floor area devoted to the hotel uses. The overall floor area ratio for the site will be 3.04.

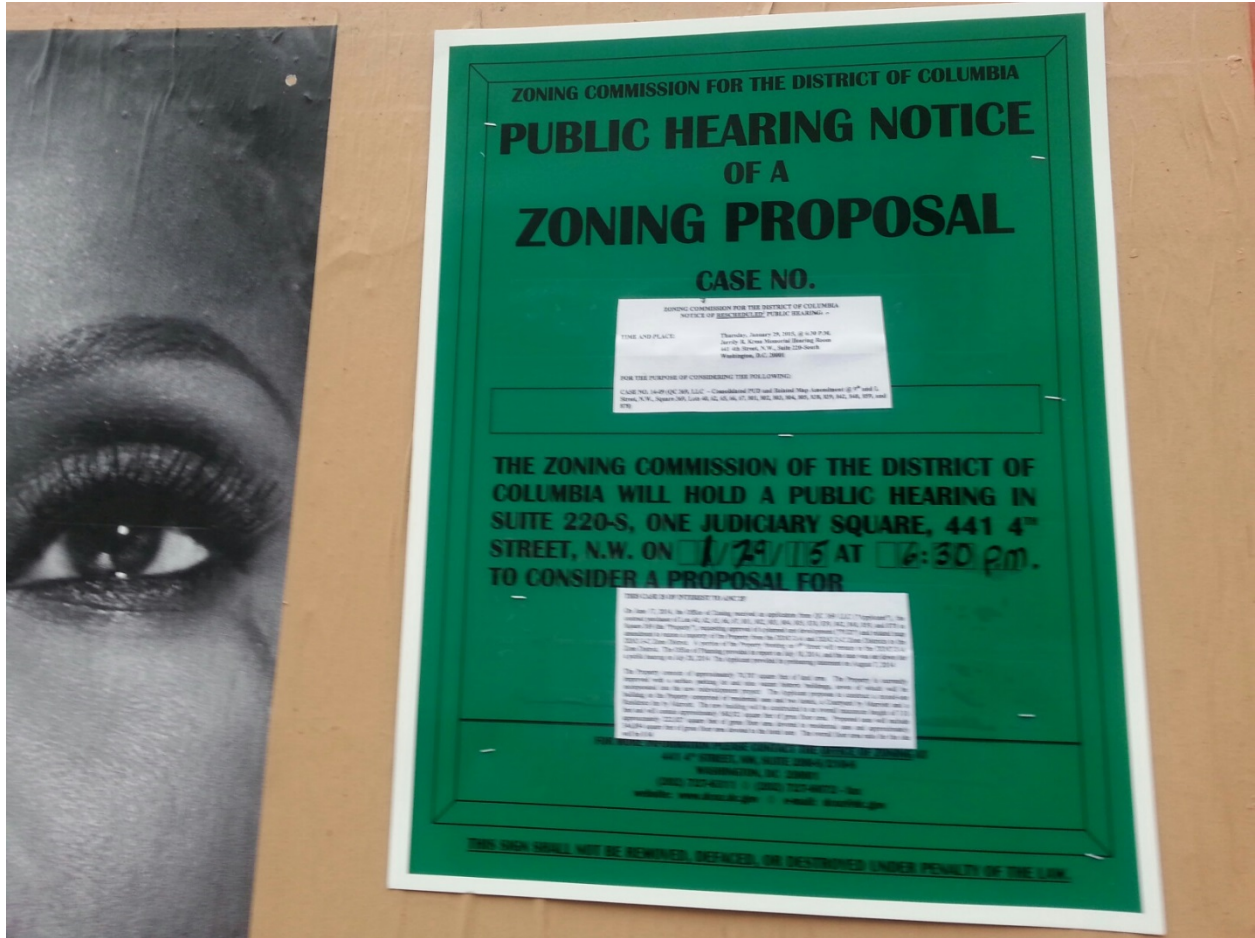
