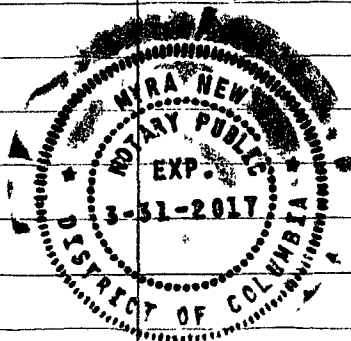



crime personally to court his self, Everything is racist

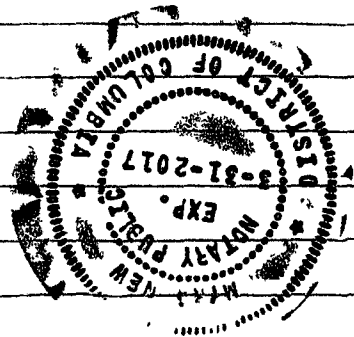

Dear Mr. Meers,

I write to respond to your letter of November 19, 2014 to the Brookland Manor Residents Association (BMRA) regarding Mid-City's proposed plans for the redevelopment of Brookland Manor.

We are most concerned with Mid-City's plans for affordable housing in the proposed redevelopment. In your November 19 response to the BMRA's October 2 letter and list of goals and priorities regarding the redevelopment of Brookland Manor, you note that the new development will contain up to 2,200 units, 440 of which would be "affordable." Of those affordable units, 373 represent a continuation of the current project-based Section 8 contract and 67 units "will accept vouchers." We are concerned about this effective reduction in affordable units planned for the new development. While we appreciate that the 373-unit Section 8 contract will be preserved, we are concerned that the 162 units currently covered by the 236 mortgage will be unaffordable to low, very low, and extremely low income tenants, given the much higher rents projected for the remainder of the 2,200 units. The 67 units that "will accept vouchers" give us no comfort, given that every unit in the District must accept vouchers. If you mean that the rents in only 67 of the remaining 1,827 units will be within the limits allowable for vouchers, then we are further concerned that the majority of the 142 tenants under the DCHA Voucher Contract and 20 market rate renters at Brookland Manor will be priced out of the new development.

Regarding the preservation of the Section 8 contract at the property, we are concerned about the proposed shift toward specifically senior housing and the elimination of unit sizes for large families. Mid-City states that the 373 Section 8 units in the new development would be divided between a 200-unit senior building and 173 units spread over other buildings. Mid-City also states that the new development will have no apartments larger than three bedrooms; 134 Brookland Manor families currently live in 4 and 5 bedroom units. Mid-City plans to reduce the number of 3 bedroom units in the new development; there are currently 75 at Brookland Manor. While Mid-City has not stated the unit sizes it proposes for the senior building, such buildings usually have only studio and one bedroom units. What will happen if a senior's household consists of other members such as children or grandchildren? How will these and other large families be housed in the new development? We are also disturbed by Mid-City's rationale for the elimination of 4 and 5 bedroom units for large families. We disagree that these units are "not an ideal housing type for larger families and there are adverse impacts on the remainder of the community." Large, low-income families have been consistently pushed out of the District for years by the elimination of large units during redevelopment at other properties. The fact that you will only guarantee the right to return to the property for tenants currently in one and two bedroom units further illustrates the lack of commitment to allow Brookland Manor families to remain part of their community.

Further, we do not believe in the viability of Mid-City's plan for those families in 3, 4, and 5 bedroom units that would not be able to be rehoused in apartments in the proposed development. Mid-City states that they will work with various government and private organizations to prepare them for homeownership opportunities in

newly built townhouses or provide vouchers to find housing elsewhere. Given that these families have to meet low-income guidelines to live in their current apartments, we are concerned that Mid-City has not thought through nor consulted with the referenced organizations adequately regarding the house pricing and mortgage affordability hurdles that tenants might face.

We worry that these vague assurances mask intent to eliminate large, low-income families from the new development and the community. As we have seen—and the *Washington Post* and *CityPaper* have reported—with the PUD plans at Temple Courts and other New Communities (or similar) developments, promises to the residents and communities to maintain affordability, retain and rehouse current residents, and foster homeownership have consistently failed in their implementation.

The Residents Association is very concerned that Mid-City has represented to the press, the Zoning Commission, and the Office of Planning that they have community support for these plans. At the Zoning Commission's November 24, 2014 meeting, multiple commissioners expressed concern that Mid-City had given no proof for their assertions of community support. Multiple commissioners also noted their desire for there to be at least a one-for-one replacement of affordable units at the property. Based on the questions asked by the commissioners, we wonder if they had been provided the affordability details contained in Mid-City's November 19 letter to the Residents Association.

These plans to effectively eliminate 162 affordable units and to eliminate apartments for large families are in direct opposition to the goals expressed in our October 2 letter to Mid-City and represent a refusal to consider input from the residents of Brookland Manor. Until Mid-City sits down to negotiate the future of Brookland Manor with its residents, they will not have the support of the people most directly affected by this proposed PUD.

Under PUD regulations, Mid-City must provide significant public benefit in exchange for the zoning changes it is requesting. As the group with the most obvious party status before the Zoning Commission, the Brookland Manor Residents Association does not believe that the effective reduction of affordable housing at the property demonstrates such a public benefit to the current residents.

We ask that you review the enclosed list of priorities and goals, which, we believe, are essential to ensuring that Brookland Manor remains a place that is affordable and welcoming to current and future tenants. We have reached out to a variety of DC and federal officials and affordable housing advocates to make our case for our priorities and goals. We will be in touch in the coming weeks to schedule meetings with you to discuss these issues further.

Frequently Asked Questions

When will construction start?

Phased construction will not start before August 1, 2017.

What building will be built first?

Mid-City is committed to building a new affordable senior building in the first phase of the project. This building will consist of 175-200 units to be occupied by existing residents who elect to move into the new building.

Do I have to move into the senior building if I am over 62 years old?

No, you do not.

Will relocations be required and will they be on site or off site?

Relocations will be required. Our objective is to complete them on site (based upon availability of units) and to minimize the number of moves and disruption to our residents.

Who will pay for the relocation?

Mid-City will pay for all packing, moving, and other reasonable required relocation expenses. For anyone that must be relocated, we will try to provide plenty of advance notice; however, we will retain the final decision about where on the property residents will be relocated.

Will I be able to stay at the property (or come back) once it is rebuilt?

Yes, all residents in good standing have the right to return to the newly constructed buildings once they are completed.

What does "good standing" mean and what are the conditions for me to return?

All residents are required to abide by the terms of the lease they have executed already. All Section 8 and DCHA Voucher residents are additionally required to go through the annual certification processes required by those programs.

What will my new unit be like and what will the rent be upon my return? Still 30% of income?

The new units will have a full range of modern features and amenities. For those with Section 8 or DCHA Voucher subsidies your portion of the rent will continue to be 30% of your income as provided in the annual certification.

Are you keeping the Section 8 contract at Brookland Manor?

We have an agreement in principle with HUD to retain the project based Section 8 ("in house") contract for the new development for the long term. This covers 373 of the units on the property.

What happens to me if I have a DCHA Housing Choice Voucher?

You will have the same flexibility that you have now in being able to choose where you live. DCHA voucher residents are welcome in the new community and are also assured the right to return. In the coming months, we will explain and explore all options with these residents on an individual basis.

What happens to those of us who pay full market rent without getting any subsidy?

The new development will include provisions to provide affordable housing to residents at 50% and 80% of area median income. Based upon your circumstances and your family objectives, we expect to be able to find an affordable slot to accommodate your desire to remain at the property in new housing at an "affordable" rent.

I heard that you aren't building new 4BR and 5BR units. Is that true and what happens to those families when the construction begins?

It is true that we will not be building new 4BR and 5BR units. We will be meeting with these households in the coming months on an individual basis to hear what their objectives might be and how we can accommodate their ultimate return to the property. Many of these families can be accommodated in smaller units, some of the multi-generational families may choose to be rehoused in separate apartment homes, some residents may be in a position to buy a larger townhouse unit in the new development, and others may opt to take their DCHA voucher to a community of their choice. We will meet with each and every one of these families privately to determine what their goals are and what makes sense to them.

I am currently in a 1BR unit and I need more space. What about me?

We will be meeting with individual households to determine their occupancy requirements and we understand that some households need more space to accommodate their growing families. We will make best efforts to work with HUD and DCHA to accommodate these families.

How much affordable housing will be here upon the completion of the project?

Mid-City has committed to provide newly constructed affordable housing to include Section 8 and DCHA Voucher units. There will be affordable housing for approximately 424 households upon the completion of the project.

Will vouchers be given to me if I want to move elsewhere?

Currently, 373 of the approximately 497 occupied units are assisted by the project based Section 8 contract (or "in house" section 8 as some call it). The subsidy for these units is not portable and there will not be vouchers provided to go elsewhere. Most of the remainder of the residents already have DCHA Vouchers and those will continue to be portable in the same way that they are right now.

If I want to stay at the property, do you have any suggestions for me on what I need to do in the coming years?

It is important to pay your rent on time and abide by the terms of your existing lease. It is also essential that you continue to provide annual certifications in a timely manner. People who are out of compliance with lease and other terms of their tenancy should use this time to cure their defaults and otherwise prepare for future opportunities in the New Brentwood Village.



- 7 If you are being evicted because you owe rent, you should tell the judge if your apartment has mice or roaches, inadequate heat or hot water, or other unsafe conditions (housing code violations) If the judge finds that your landlord has violated the housing code, the amount of rent you owe can be reduced (Read the section on Repairs for a list of housing code violations)

You can challenge a notice to vacate by asking for a trial when your landlord sues you in landlord-tenant court or by filing a form called a Tenant Petition with the RACD (202) 442-4610

If your case goes to trial, you may still be required to pay your rent, but you will pay it into the Court Registry under a “Protective Order” Paying your rent on time under a “Protective Order” is crucial If you miss any payments or your payment is late, you may lose your case If the judge decides at the trial that substantial housing code violations existed, the judge may reduce your rent or order the landlord to pay back some of the rent you have paid in the past If you made rent payments to the court under a Protective Order, the judge will decide what portion of the money the landlord is entitled to and what portion will be returned to you

D. Legal Reasons for Eviction

Under DC law, your landlord may evict you only for the reasons listed below The landlord must give you notice to vacate before you can be evicted unless you have not paid your rent and you expressly waived your right to receive notice after nonpayment Notice requirements are different for each reason for eviction The number of days notice you must be given before you have to move is listed below after each reason for eviction Any part of your lease that says you can be evicted without notice is invalid, unless it is for not paying your rent

- 1 **Nonpayment of Rent:** Your landlord can evict you if you do not pay your rent (30 days notice is usually required unless you waived the right to receive notice when you signed your lease.)
- 2 **Violation of Lease Obligation:** Your landlord can evict you if you continue to violate an obligation, rule, or regulation that is listed in your lease or rental agreement. Before evicting you, your landlord must give you written notice (a “Notice to Cure or Vacate”) stating that you are violating the lease or rental agreement and that you have 30 days to correct the problem If you do not correct the problem within 30 days the landlord may then file suit against you (30 days notice is required.)
- 3 **Illegal Act:** You can be evicted if a court has decided that you have committed an illegal act in your apartment or building (30 days notice is required.)
- 4 **Landlord or Owner’s Personal Use:** You can be evicted if the landlord or owner of your apartment wants to live in your apartment. You cannot be evicted if the landlord’s friend wants to live in the apartment. (90 days notice is required)
- 5 **Sale of the Apartment:** Your landlord may evict you if the landlord sells your apartment to someone who will live in your apartment Your landlord cannot use this reason unless the landlord gives you the first chance to buy your apartment (90 days notice is required.) (See the section on How To Buy Your Building for details on the tenant purchase process)
- 6 **Unsafe Renovations.** You can be evicted if your landlord wants to make renovations to your apartment or building that cannot be done safely while you are living there The renovations must be approved in writing by the RACD before any evictions occur When the renovations are complete, you have the absolute right to return to your old apartment If the renovations were done to comply with housing regulations, you have the right to re-rent at the same price and under the same obligations that were in effect when you were evicted (120 days notice is required)

- 7 **Demolition:** Your landlord may evict you to demolish your apartment for new construction. Your landlord cannot use this reason unless your landlord first gives you the chance to buy your apartment (180 days notice is required.) (See the section on How To Buy Your Building for details on the tenant purchase process.)
- 8 **Substantial Rehabilitation:** You can be evicted if your landlord wants to substantially rehabilitate your apartment. Before eviction the rehabilitation must be approved in writing by the RACD. When the renovations are complete, you have the absolute right to immediately return to your old apartment; however, the landlord may increase the rent (120 days notice is required.) (See Section on Rent Control.)
- 9 **Discontinued Housing Use:** You can be evicted if your landlord wants to discontinue renting your apartment. Your landlord cannot use this reason unless your landlord first gives you the chance to buy your apartment (180 days notice is required beginning after expiration of tenant purchase rights.) (See the section on How To Buy Your Building for details on the tenant purchase process.) The landlord cannot use the apartment for any purpose for one year following the date you move out. In addition, if after that one year period the landlord decides to use the apartment for residential purposes, it must be as rental housing and not as a condominium or cooperative.
- 10 **Conversion to a Cooperative or Condominium:** You may be evicted if the landlord converts the property to a condominium or cooperative. In order to convert the property, there must be an election and a majority of the eligible residents need to vote in favor of conversion. Even if the conversion vote is successful, your landlord cannot evict you unless your landlord first gives you the chance to buy your apartment (120 days notice is required.) (See the section on Condo And Coop Conversion Controls for details on the conversion process.)

E. Relocation Assistance

If you are evicted due to demolition, substantial rehabilitation, discontinued use, or conversion of your apartment building, you can receive assistance from the Department of Housing and Community Development, (202) 442-7200. The available assistance includes help in finding available housing, information on public housing, and other advisory services. In addition, the landlord is required to give you money to help you move. If your eviction is due to demolition, substantial rehabilitation, or discontinued use of the building, you should receive \$75 for each pantry, kitchen, storage area, or utility room in their apartment that is over 60 square feet and \$150 for every other room over 60 square feet (these amounts are subject to change.) If your eviction is due to conversion, you should receive a minimum of \$125 and no more than \$500.

F. Drug Related Evictions

The District of Columbia has enacted special rules for evictions of tenants or occupants of an apartment used as a "drug haven." The court procedures in these types of actions take less time and the tenants' defenses are limited. A landlord can begin an action for possession of a rental apartment, or the Mayor can begin an action for eviction if the Superior Court of the District of Columbia determines by a "preponderance of the evidence" that an apartment is a "drug haven." (See section below entitled Drug Related Evictions.)

G. What You Should Do When You Get an Eviction

You must be in court by 9:00 a.m. and answer not be late. If you are late or do not answer

You may be asked to speak to the landlord's lawyer only on the advice of the landlord's lawyer. You may be in the landlord's best interests but instead may be in the landlord's best interests. Call the Agencies and Information section of the Department of Housing and Community Development for help. If you did not already get legal aid, call the court from D.C. Law Students in Court.

The landlord's lawyer may ask you to sign a "Judgment Praecipe" or Form (4) to settle the case. If you sign, you lose all your rights to challenge the judge about any housing code violations or conditions of the consent agreement you can be required to make a partial payment, or make a late payment, you must wait and tell the judge that you want to have

I. You Have a Right to a Trial

D.C. law gives all tenants the right to a trial on the landlord's complaint. A trial gives the tenant the right to request a jury trial, however the filing fee for a jury trial is \$75, but if you cannot pay the court may waive the filing fee for a jury trial.

You can stay in your apartment while you are in court to require that you pay all of your rent. Order. You must make these protective orders your right to a trial.

J. What Happens if You Lose a Trial

If you lose at trial, your landlord will win a "writ of eviction" authorizing the landlord to remove you from the apartment. If you are wrong, you have the right to appeal if you are on significant legal error. Get legal help.

In addition, you will have a "money judgment" unpaid money judgment can affect your credit.

K. What Is A Writ Of Eviction

This "writ" is a court paper which gives the landlord the right to remove you and your possessions from your home and from there it is sent to you by mail. A writ is entered after the court has entered a judgment against you.

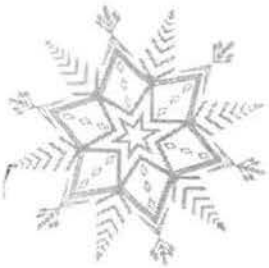



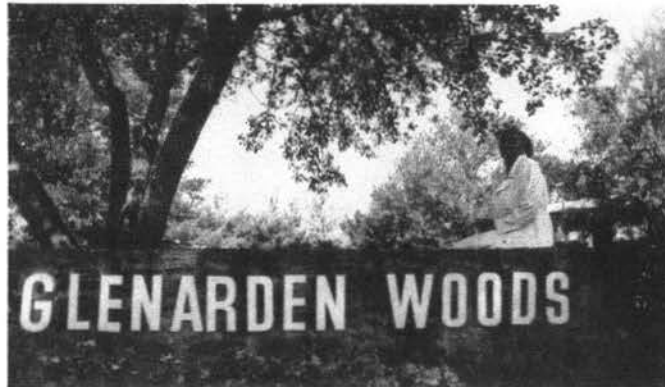
