NOTICE OF PROPOSED RULEMAKING

Z.C. Case No. 14-20

(Map Amendment to Rezone a Portion of Square 1070)

The Zoning Commission for the District of Columbia, pursuant to its authority under § 1 of the Zoning Act of 1938, approved June 20, 1938 (52 Stat 797; D C Official Code § 6-641 01 (2008 Repl)), hereby gives notice of its intent to amend the Zoning Map. If adopted, the amendment would rezone Lots 38, 39, 73–76, 80–86, and 94 on Square 1070 from C-2-A to the R-4 Zone District.

Final rulemaking action shall be taken not less than thirty (30) days from the date of publication of this notice in the *D C Register*.

The Zoning Map is proposed to be amended as follows:

Rezone Lots 38, 39, 73–76, 80–86, and 94 on Square 1070 from the C-2-A Zone District to the R-4 Zone District.

All persons desiring to comment on the subject matter of this proposed rulemaking action should file comments in writing no later than thirty (30) days after the date of publication of this notice in the *D C Register*.
