At its regularly scheduled meeting of Tuesday, March 17, 2015, (notice of which was properly given and at which a quorum of nine of ten members was present), Advisory Neighborhood Commission 5E voted unanimously (9-0) to support the Howard University Central Campus Plan Amendment in Case No. 11-15D and the Barry Place Partners Planned Unit Development in Case No. 14-21.

In addition, ANC 5E supports the community benefits package proffered by the developer in Case 14-21 and accepted by ANC 1B.
