






FLOOR PLANS - LEVEL 9 A-11a





A-12 FLOOR PLANS - ROOF (WEST), LEVEL 10 (EAST)














PIERCE STREET - FINAL CONDITION SECTION








SOUTHWEST BUILDING - EAST ELEVATION






SOUTHWEST BUILDING - SOUTH ELEVATION


