OneDC in association with DC for Reasonable Development requests the Commission reconsider and Rehear the ZC Case No. 16-07. Following from the instructions on Form 153, we cite DC Municipal Regs 11-2400.2, .3, .4, and .8, among others, as well as 11-DCMR-101.2, and DC Code 6-641.01, and .02, we call upon the Commission to accept this Request for Reconsideration and rehear this case to address the injury on OneDC and DC4RD members living in the Shaw community around the PUD site according to the law which requires a proper evaluation of impacts and a comprehensive review of affects on the area surrounding the PUD site by the PUD application. These impacts include cumulative impacts of this project among others in the immediate area on: environment (air, water, noise, refuse, health impacts, light, etc.) as well as impacts on existing community services like public transit ways, infrastructure, emergency responders and response time and impacts to crowding in local schools, libraries, and other community facilities that exist now but will be stressed by overdevelopment. There is also deep concern about the land value destabilization and displacement pressures on existing residents and small businesses in the Shaw area. Given these issues, we are asking the Commission to reconsider the order and rehear the case.
